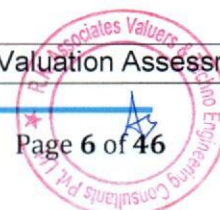

	<p>This Valuation report has been prepared for the industrial property situated at the aforesaid address having total land area admeasuring 384.40 sq.mtr./ 459.73 sq. ft.</p> <p>The identification of the property is done with the help of owner's representative Mr. Harish Khanduri. The valuation of the property is done on as-is where-is basis.</p> <p>The property details like ownership, address, and land area has been taken on the basis of copy of TIR Dated – 17-02-2009, provided to us by the bank/client.</p> <p>During our site visit of the subject property we observed that the nearby properties are being used as a industrial unit and the subject property is currently under renovation. The property is constructed with RCC & Tin shed technique and is comprised of G+2 Floors, where GF and FF are constructed with RCC and SF is constructed with Tin Shed. Since there are only 2 floors given in the approved map and the covered area available at site is more than the area given in the approve map, so, the covered area considered for the purpose of valuation is as per the approved map provided to us by the bank/ client.</p> <p>The subject property is located in the developing area of Pargana – Mohebewala Industrial area and can be approached through Titan road which is approx. 25 ft. wide. And is located approx. 150 mtr. away from main Saharanpur - Dehradun Road.</p> <p>In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Our responsibility will be only related to the valuation of the property shown to us on the site and not regarding matching from the documents or searching the property from our own. 20.	This valuation report is not a qualification for accuracy of land boundaries, schedule (in physical terms), dimensions & identification. For this land/ property survey report can be sought from a qualified private or Govt. surveyor.
21.	This Valuation report is prepared based on the facts of the property on the date of the survey. Due to possible changes in market forces, socio-economic conditions, property conditions and circumstances, this valuation report can only be regarded as relevant as at the valuation date. Hence before financing, Banker/ FI should take into consideration all such future risk and should loan conservatively to keep the advanced money safe in case of the downward trend of the property value.

It is requested from the Bank to cross check from their own records/ information if this is the same property for which Valuation has to be carried out to ensure that owner has not misled the Valuer company or misrepresented the property due to any vested interest. 24.	In India more than 70% of the geographical area is lying under rural/ remote/ non municipal/ unplanned area where the subject property is surrounded by vacant lands having no physical demarcation or having any display of property survey or municipal number / name plate on the property clearly. No detailed analysis, audit or verification has been carried out of the subject property.
