

This opinion on Valuation is prepared for the flat situated at the aforesaid address having total super area admeasuring 818 sq.ft (75.99 sq.mtr) as per the conveyance deed provided to us by the bank.

The property is currently under banks possession and at the time of inspection no representative from M/s. Bhagwati Lifestyle was present. The subject property was locked and was identified and shown by the bank manager Mr. Arvind Shaw. The said property was not accessible.

The subject property is located in Kestopur region of Kolkata and is around 200m far from Thakdari road which is around 30 feet wide.

The identification of the property is done by the banker. The property was locked at the time of site survey, our surveyors were not even allowed to enter the building the premises.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Our responsibility will be only related to the valuation of the property shown to us on the site and not regarding matching from the documents or searching the property from our own. Banker to verify from district administration/ tehsil level the identification of the property if it is the same matching with the document pledged.

This report only contains general assessment & opinion on the Guideline Value and the indicative & estimated Market Value of the property of which Bank/ customer asked us to conduct the Valuation for the property found on as-is-where basis as shown on the site by the Bank/ customer of which photographs is also attached with the report. No legal aspects in terms of ownership or any other legal aspect is taken into consideration.
