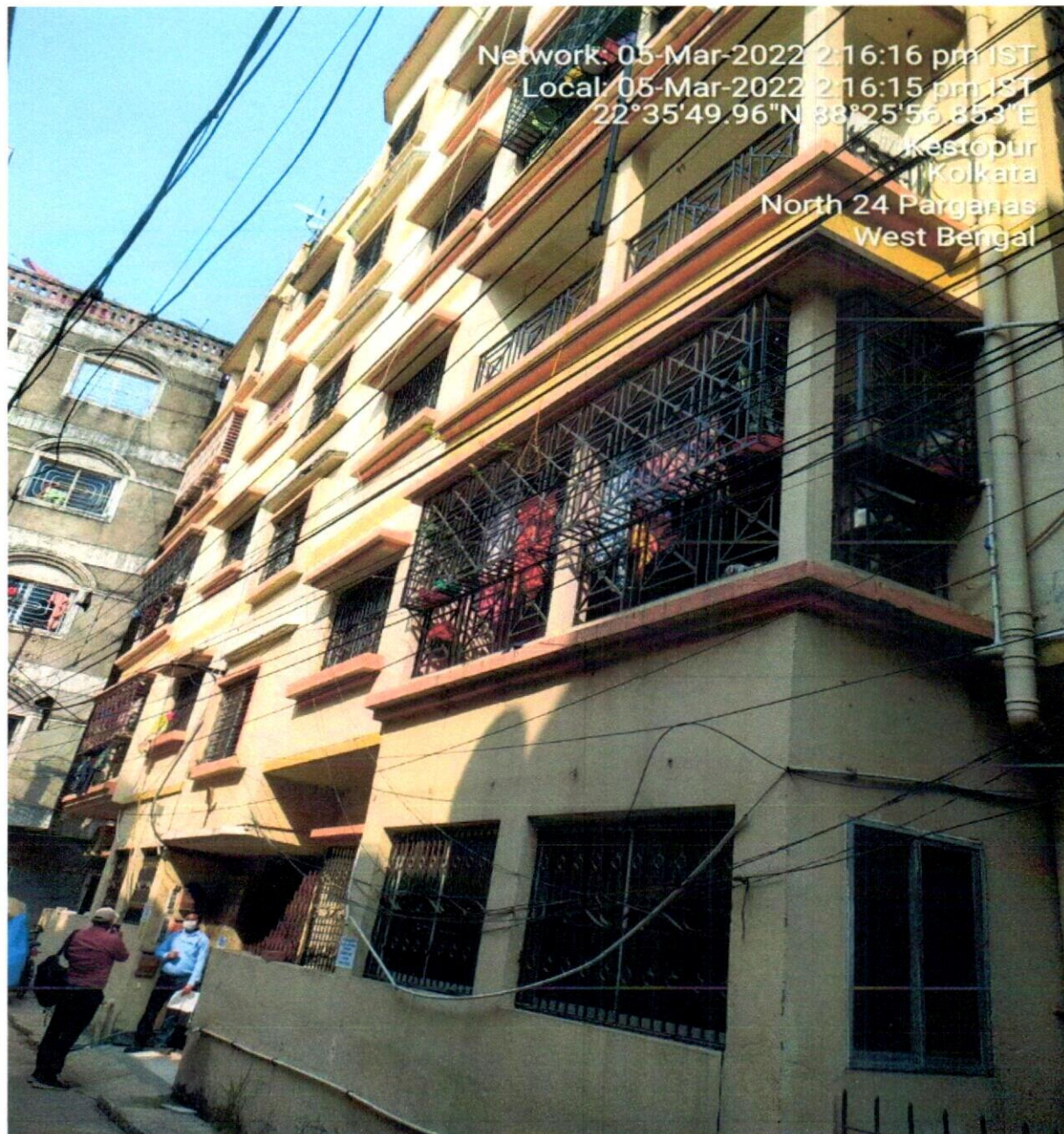

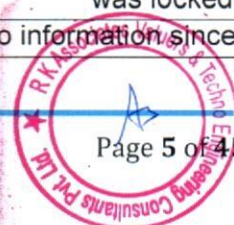

The said property was not accessible.</p> <p>The subject property is located in Kestopur region of Kolkata and is around 200m far from Thakdari road which is around 30 feet wide.</p> <p>The identification of the property is done by the banker. The property was locked at the time of site survey, our surveyors were not even allowed to enter the building the premises.</p> <p>In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. 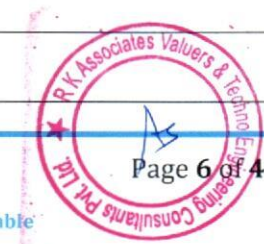

Also as per the discussion with the local market participants we came to know that there no such demand of the flats in this area and many such type of properties are lying vacant. This will have adverse effect on the market rate for this flat and keeping in view all the factors we have given 10% of discount on the rates which we are getting from the market, hence we have adopted Rs.2,800/- per sq.ft. for the purpose of valuation.

	property owners many times extend or make changes in the covered area/ layout from the approved/ applicable limits.
