Brief description of the property

This opinion on Valuation is prepared for the flat situated at the aforesaid address having total super area admeasuring 800 sq.ft (74.32 sq.mtr) as per the conveyance deed provided to us by the bank.

The property is currently under banks possession and at the time of inspection no representative from M/s. Bhagwati Lifestyle was present. The subject property was locked and was identified and shown by the bank manager Mr. Arvind Shaw. The said property was not accessible.

Flat is situated on the fourth floor of Chawla Apartment. The identification of the property is done with the help of bank representative. The property was locked at the time of site survey. We are not allowed to enter the flat.

The subject property is located in Kestopur region of Kolkata and is around 500m away from Thakdari Road which is around 15 feet wide.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Our responsibility will be only related to the valuation of the property shown to us on the site and not regarding matching from the documents or searching the property from our own.
