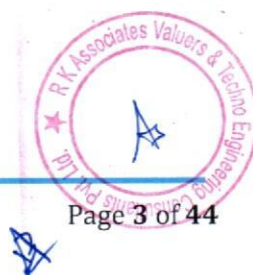

This opinion on Valuation is prepared for the commercial shop situated at the aforesaid address having total covered area admeasuring 596.25 sq.ft (55.393 sq.mtr) and 656.07 sq.ft.(60.951 sq.mt.) As per the sale deed provided to us by the bank.

During our site survey no utility bills were provided to us by the client. It's requested that the bank take the same from the client to check whether any discrepancy in the address mentioned in the property documents and the property shown to us at the site.

This commercial shop is situated on the ground floor of City Pride Complex. The subject property is currently being used as a storage place as shown to us. It is adjoined with Prem Mandir Road which is 30 feet wide. Location of the subject property is in a good commercial area.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Our responsibility will be only related to the valuation of the property shown to us on the site and not regarding matching from the documents or searching the property from our own. Banker to verify from district administration/ tehsil level the identification of the property if it is the same matching with the document pledged.

This report only contains general assessment & opinion on the Guideline Value and the indicative & estimated Market Value of the property of which Bank/ customer asked us to conduct the Valuation for the property found on as-is-where basis as shown on the site by the Bank/ customer of which photographs is also attached with the report.
