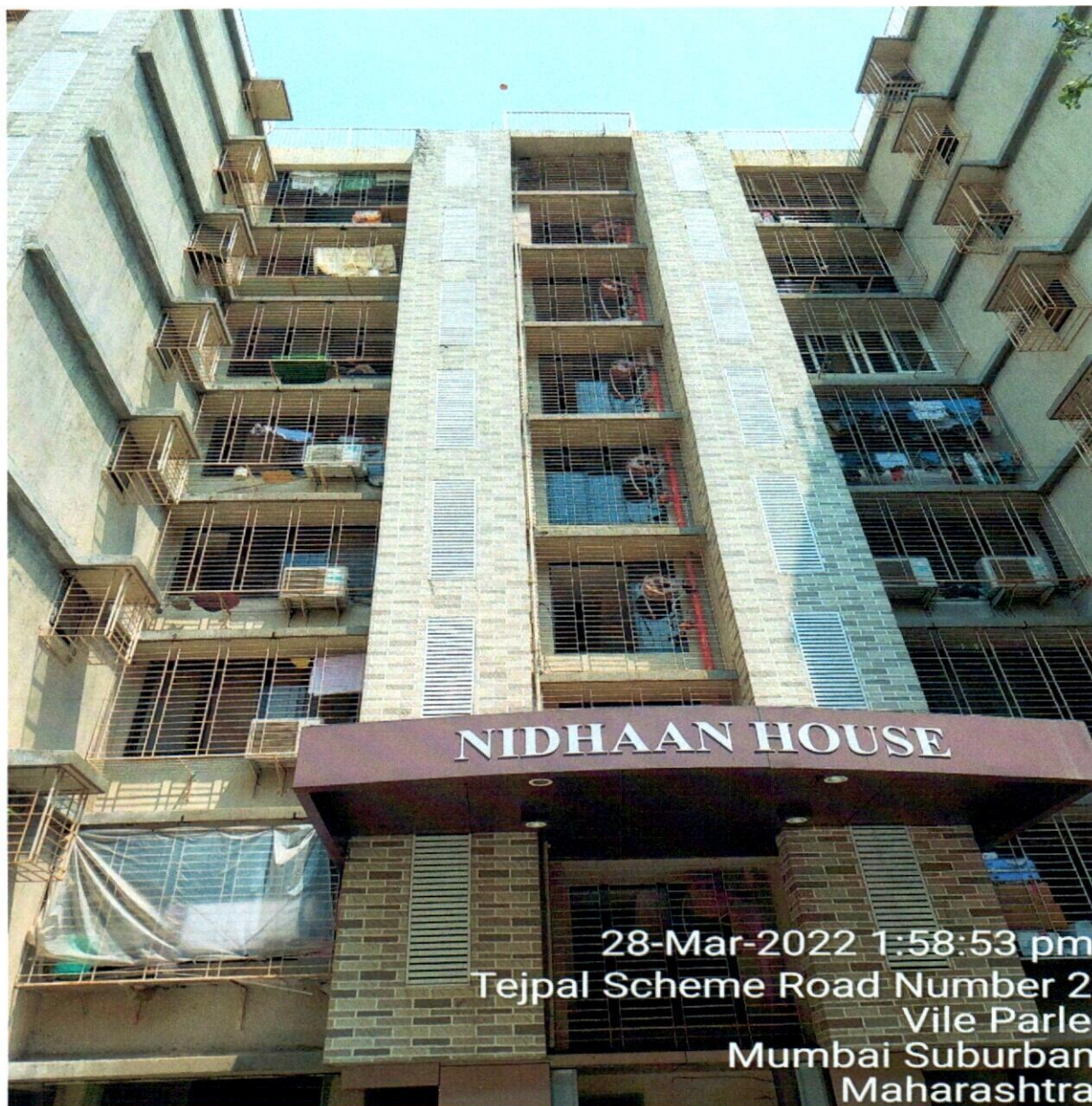

During our survey we found that unit 201 and 202 are combined and being used as hostel, unit 301 and 302 are also combined and being used as office space. Unit 402 used as hostel and unit 502 is currently under maintenance.

The subject property is around 200 mtr. from Shahaji Rage Marg road which is around 40 ft. in width. The subject property is amidst good residential and commercial area.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Integrity and Fairness

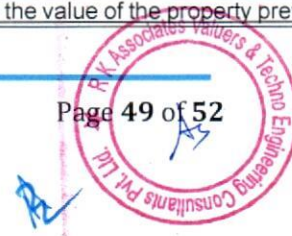




