### 3. FLOW OF TITLE

The survey No. 289/3 was earlier a part of Survey No. 289 and 289/1

The subject property bearing survey no.289/3, admeasuring 1.500 hectares is currently owned by M/s Kshema Power and Infrastructure Company Private Limited, who purchased the same from Smt Ramibai Jat, W/o Sh. Gopal Ji vide a registered sale deed dated 23.08.2016 (hereinafter referred to as said property). The electronic registration number of the sale deed is MP319522016A1492093. The mutation order in favour of M/s Kshema Power and Infrastructure Company Private Limited has been produced.

Smt Ramibai Jat, W/o Sh. Gopal Ji is recorded as the owner of the subject property since the year 2011-2012 till the year 2015-16 for land admeasuring 1.500 Hectares. It appears from the mutation record that Smt. Rami Bai purchased the same from Shri Deepak vide sale deed dated 1<sup>st</sup> February, 2012. The sale deed dated 1<sup>st</sup> February, 2012 has been produced.

It appears from the mutation order that Shri Deepak purchased the said property from Shri Umrao Singh vide sale deed dated 25<sup>th</sup> May, 2011. The sale deed in favour of Shri Deepak has been produced. The said Shri Deepak is recorded as owner in revenue records for the period 2010-11.

Prior to the ownership of Shri Deepak the subject land was a part of large tract of land admeasuring 3.230 hectares in the name of Shri Bhawar Singh and Umrao Singh since 1983-84 till 1995-1996. The subject land admeasuring 1.330 hectares was given survey no. 289/2 and land admeasuring 1.900 hectares continued in the name of Shri Bhawar Singh and another and was known as survey no. 289/1.

It appears from mutation order that the sale deed has been executed in favour of Shri Deepak only by Shri Umrao Singh. It is submitted that Shri Bhawar Singh was a joint owner of property, who should have joined in execution of sale deed.

The Revenue records of the year 2016-17 reflecting the name of M/s Kshema Power and Infrastructure Company Private Limited as the owner are available.

#### **4. NATURE OF THE TITLE OF THE OWNER**


M/s Kshema Power and Infrastructure Company Private Limited is the absolute owner of the subject land which is Industrial in nature. The sale deed states the possession of the subject land is with M/s Kshema Power and Infrastructure Company Private Limited, the same be verified on site.

#### **5. ENCUMBRANCES**

The subject property is free from encumbrance.

It is advisable to verify the RinPustika of Kshema Power and Infrastructure Company Private Limited to determine if any encumbrance has been created by them.
