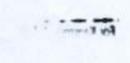

LEASE DEED

In addition to the other specific clauses relating to cancellation, the Authority/Lessor, as the case may be, will be free to exercise its right of cancellation of lease/allotment in the case of :

Allotment being obtained through misrepresentation/suppression of material facts, mis-statement and/or fraud.

Any violation of directions issued or rules and regulation framed by 2. any Authority or by any other statutory body.

Default on the part of the applicant/allottee/lessee 3. breach/violation of terms and conditions of registration/allotment/lease and/or non-deposit of allotment amount.

If at the same time of cancellation, the plot is occupied by the Lessee thereon, the amount equivalent to 25% of the total premium of the plot shall be forfeited and possession of the plot will be resumed by the Authority with structure thereon, if any, and the Lessee will have no right to claim compensation thereof. 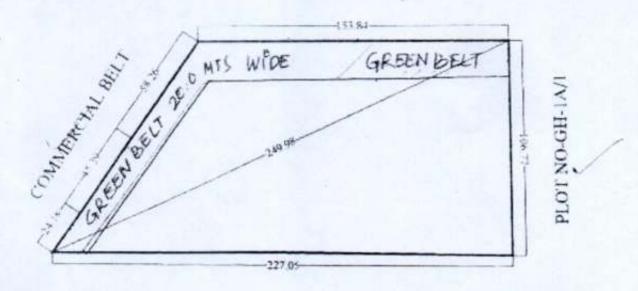
