Section 1 - Executive Summary

During the review period, ~ INR 3.83 Cr of work was done by the EPC contractor as certified internally by the Concessionaire. The main works carried out were GSB, WMM & DBM in Shitalpur Bypass and Embankment construction in RoB, Major Bridge & Flyover approaches at km 143 &158, km 209, km 204 & km 207 respectively. As per Concessionaire, physical progress stands at 86.55% whereas the financial progress is 89.32%. Cumulative value of work done as per our records stands at ~ INR 282.1 Cr excluding CoS works. The Concessionaire is awaiting NHAI's decision on Extension of Time [EoT] on grounds of Force Majeure of COVID-19. For the completion of PCOD work as per the agreed upon timeline up to November 2021, the monthly amount outlay should be INR 16 Crore. However, the outlay for the month of June 2021 is INR 3.8. Thus, we anticipate a delay in the completion of work.

Following are some project updates and concerns on governance improvements and works:

- 1. <u>Absence of Independent Engineer (IE):</u> Existing IE (Stanley Consultants) withdrew his team from the project w.e.f 01-Jan-21. In the absence of an IE on the Project, critical activities such as monthly RA bill certification, contract administration, construction supervision and PCOD tests are unattended
- 2. <u>Shortfall Financing Proposal</u>: The Concessionaire is yet to be submit a proposal or share ideas to arrange funds for the expected shortfall of 18 Cr after disbursement of remaining OTFIS and Debt. Break up of fund requirement /availability as on 10.06.2021 is given as under:-

- 3. <u>Dismantling of structures & Land Acquisition</u>: Out of 66.74 Km of the Total Length required for the four laning of the Project Highway about 64.89 Km of the land was available till June 2021. This Constitutes to 97.22 % of the total land acquisition.
- 4. <u>Utility Shifting</u>: Shifting/raising of power transmission lines is expected to be complete by Aug'21 against the previous plan of 9th July;21.
- 5. CRS Approval: Pending for ROB girder launching.
- 6. <u>HSE Compliances</u>: Compliance with HSE norms is non-existent for most site activities and plant operations. Any unfortunate incident can cause loss of critical man-days and have a cost impact. There is a near zero inventory of Personal Protective Equipment (PPEs) despite our multiple escalations.












