The above prices are ex-our Chennai works. IGST @ 18% , transportation are extra at actual. Transit insurance to be arranged by you. Taxes and duties will be charged as applicable at the time of dispatch.

2. Packing Charges: Inclusive in the basic value for SKID Packing.

3. Dispatch Schedule:

12 to 14 Weeks from the date of mutually accepted Technical & Commercial clear PO along with 30% advance.

SMI is committed to above mentioned delivery & if there is delay in lifting the machine from buyer's side, an interest @ 18 % per annum for the number of days delayed will be charged. Buyer is requested to confirm the acceptance to this in Purchase Order.

4. Payment Terms:

30% advance as Security deposit (Non-refundable) along with your order and balance 70% + Taxes and duties against Proforma Invoice prior to dispatch from factory. All the payments to be made in favour of **M/s. Shibaura Machine India Private Limited**

The Advance Payment paid against Order shall not accrue any interest. We shall have the right to adjust such advances against any payment which might become due because of delay in the ordered equipment or because of any incidental expenses we may incur on your behalf. The advance shall be forfeited in case of any request for cancellation of the order is accepted by us.

Payments delayed by buyer beyond due date shall attract 18% p.a or the prevailing bank rate, whichever is higher

5. Installation & Commissioning and Training:

Supervision of Installation and Commissioning will be the responsibility of SMI Service Engineers and it will be done on FOC. All Civil, Electrical & Plumbing works will be in buyer's scope.

Training for the operational people will be provided on-site at the time of Commissioning of the machine. This will be on FOC basis.

6. Warranty Clause:

13 months from the date dispatch or 12 months from date installation whichever is earlier.

SMI exclusively warrants these products to be free from defects in materials and workmanship under normal operating conditions for the above mentioned period. Buyer's exclusive remedy is limited to repair or replacement of non-conforming parts at the original point of delivery. This warranty does not cover repair or replacement due to normal wear or routine maintenance.

7. Freight & Insurance:

Transportation charges and Transit Insurance from Chennai to your place will be extra, to be paid by you.

The Goods may be dispatched in one or separate lots at our option. If we are required to dispatch the goods on your behalf we can arrange to do so by road transport to a destination named by you, on freight To – Pay
