Sir,

Please refer to your letter no NIL dated Nil on the subject mentioned above.

This office has no objection to the construction of the Proposed Group Housing by M/S Swifttrans International Pvt Ltd & M/S Upcountry Land & Project Pvt. Ltd, herein after referred to as the applicant(s) at location Village Garhi Alawalpur, sector-24, Dharuhera, Haryana (Co-ordinates - 28° 13' 15" N 76° 47' 20" E) for a height of 39.60 Mts. (In figure) Thirty-Nine decimal Six Zero Meters (in words) above ground level so that the top of the proposed structure when erected shall not exceed 254.00 Mts (site elevation) plus (+) 39.60 Mts (height of structure).

This no objection certificate is being issued on the express understanding that the site elevation (height above mean sea level) viz 254.00 mts, relative location of the proposed building/structure & its distances and bearings from ARP/ Runway ends, as tendered by the applicant(s) are correct. If, however, at any stage it is established that the said data as tendered & which could adversely effect aircraft operations, the structure or part(s) thereof in respect of which this 'No Objection Certificate' is being issued will have to be demolished at his own cost as may be directed by the Airports Authority of India. The Applicant(s) are therefore advised in his /their own interest to verify the elevation and other data furnished for the site, before embarking on the proposed construction.

The issue of this 'NOC' is further subject to the provisions of Section 9-A of the Indian Aircraft Act, 1934 and those of any notifications issued there under from time to time and under which also the applicant may be called upon by the Airports Authority of India (National Airports Division) to demolish in whole or in part the structure now being authorized 'vide this 'No Objection Certificate'.

The use of electric fire or oil fired furnace is obligatory.

This certificate is valid for a period of five years from the date of issue. If the building /structure /chimney is not constructed & completed within the above mentioned period of five years you will be required to obtain a fresh 'No Objection Certificate' from the Airports Authority of India(National Airports Division) and/or the General Manager, Aerodromes, Northern Region. The date of completion of the building/ structure/chimney should be intimated to the Airports Authority of India and/or the General Manager, Aerodromes, Northern Region.

No light or a combination of lights which by reason of its intensity, configuration or colour may cause confusion with the aeronautical ground lights of the Airport shall be installed at the site at any time during or after the construction of the building.

Day & Night markings with secondary power supply may be provided as per ICAO Standard.

'The permissible top elevation/height includes height for superstructures (eg. Wireless, TV antennas, munties, lift machine room, overhead water tank cooling towers etc.)'

Sir,

With reference to the letter cited above, regarding permission to abstract ground water in respect of its infrastructure project at Sector 24, village Dhamhera, tehsil & district Rewari, Haryana, you are requested to submit the following information for further necessary action:

1. As per covering letter project name is given "Avalon Rangoli", which is not mentioned in the application proforma.
2. Calculation sheet to work out the water requirement of the project is not given.
3. As per point no. 3(a), about 233.76 m³/day of treated water is available for other use, which needs to be elaborated.
4. As per water balance chart about 233.76 m³/day of treated water will be discharged to natural drainage, permission in this regard needs to be submitted.
5. As per point no. 6 of proforma, year of construction of proposed tubewell is not given.
6. Hydrogeological part of the report is quite sketchy needs to be elaborated matching with the project specific information.
7. The recharge potentials worked out for the project is negligible against the ground water withdrawal by the proponent. However, revised enhanced matching recharge proposal required to be submitted in details.
8. Design of recharge structure is not clear as it does not give information on intake capacity of recharge well, basis of total number of recharge structures, location of recharge structures on site plan etc., required to be given.
9. First page of enclosed copy of approval letter is not readable, needs to be given.
10. Copy of referral letter from State Pollution Control Board/Other Statutory Agencies is not submitted, required to be given.
11. All the future correspondence should be made in the name of Regional Director.
