Brief description of the property

This Valuation report is prepared for the Industrial property situated at the aforesaid address having total land area admeasuring 3600 sq.mtr + 6900 sq. mtr. = 10500 sq.mtr/ 12556.95 sq.yds.

The two-land parcel were lease out separately and merged together to facilitate the construction of the industrial unit running over it. The subject industry is a chemical producing unit and due to which our surveyor was restricted to visit some of the sections and the plant structure was in poor condition. The boundary wall exists around the subject property and is averagely maintained.

The property details like ownership, address, land area has been taken on the basis of Lease deeds.

The lease deed was executed between Maharashtra Industrial Development Corporation Limited & M/s Shree Hari Chemicals Export Limited for a period of 95 years effective from 01-01-1988 for Plot No. A-8. And for a period of 95 years effective from 01-10-1993 for Plot No. A-9.

The subject Property structure details are considered as per the Occupation Certificate and Building Completion certificate provided.

During the site survey we have observed that actual covered area is more than the area mentioned in "Building Completion Certificate". So for the valuation purpose we have adopted area only which is mentioned in "Building Completion Certificate".

The subject property is an intermediate plot located in the developing industrial area of MIDC and can be approached from 15 ft. wide road.

The subject property is located around 1KM away from Mahad - Dapoli Road.

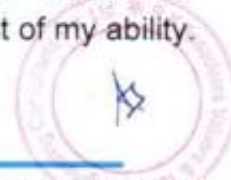

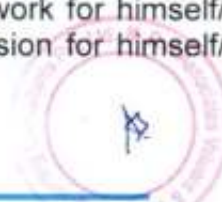

1.	This Valuation report is prepared based on the copies of the documents/ information which interested organization or customer could provide to us out of the standard checklist of documents sought from them and further based on our assumptions and limiting conditions. Verification or cross checking of the documents provided to us from the originals has not been done at our end.
