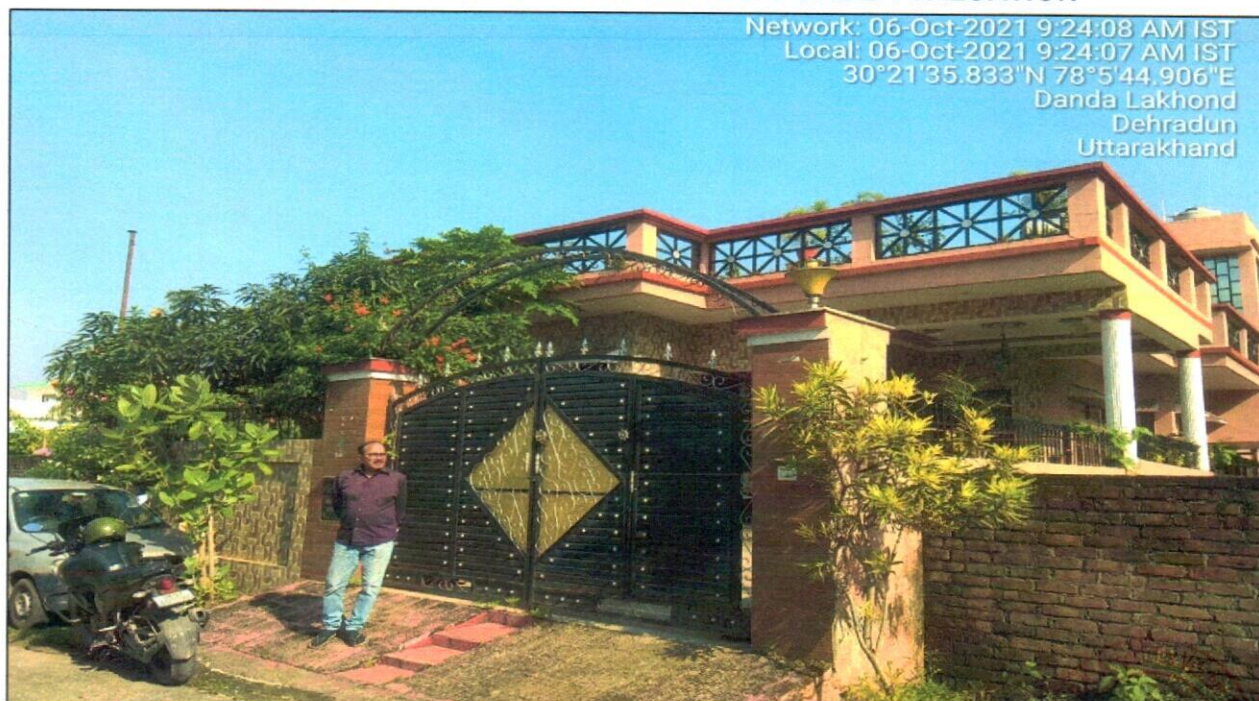

And the covered area is 150.44 sq.mtr./ 1619.32 sq.yds. including two sale deeds provided to us by the bank

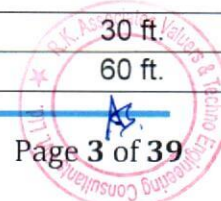
The Subject property is constructed with RCC technique and the construction is done is approx. 10-11 years old. Only ground floor is constructed and the total covered area of the property is 1630 sq. ft. as per the survey.

The subject property is located in the well-developing area of Danda Dhoran, Pargana Central Doon, District – Dehradun can be clearly approached from Vidya Sagar Marg, and is approx. 500 mtr. away from Sahastradhara road.

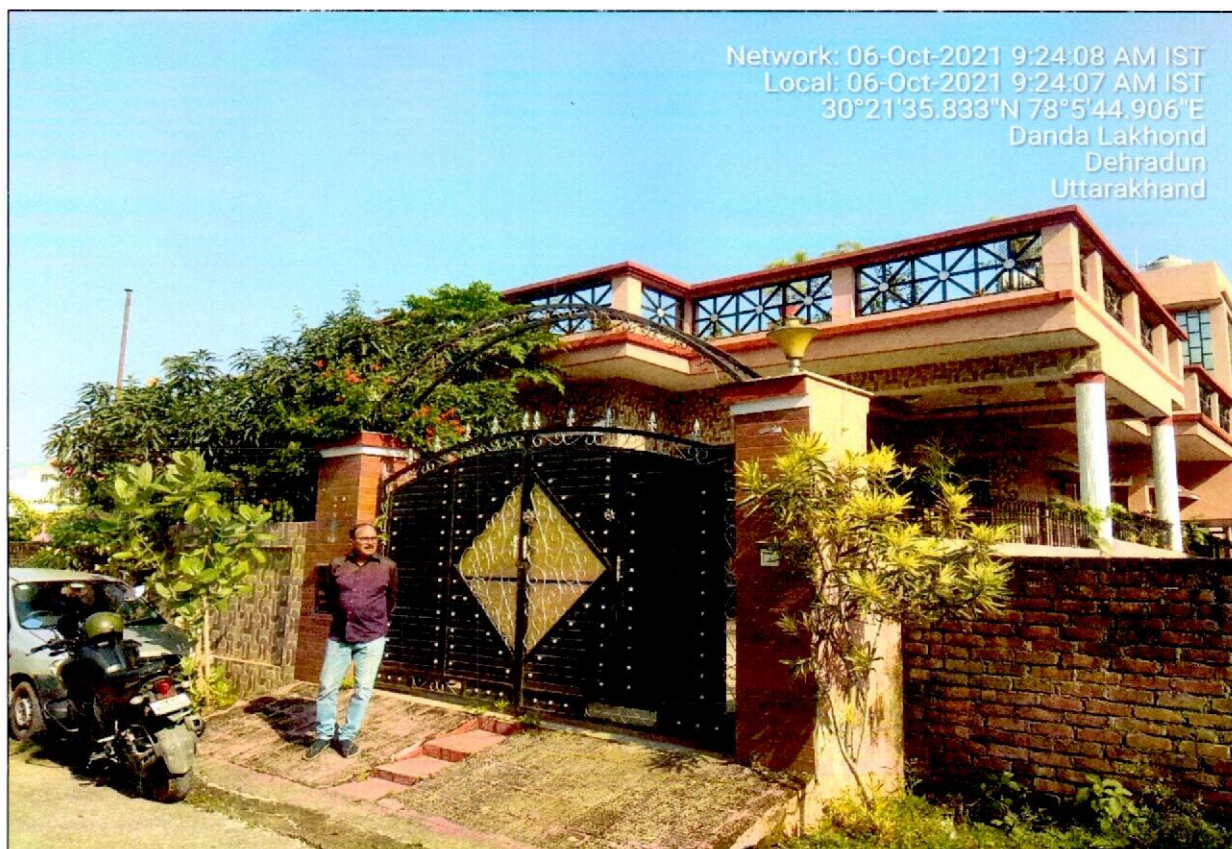
GOOGLE MAP LOCATION- ANNEXURE V

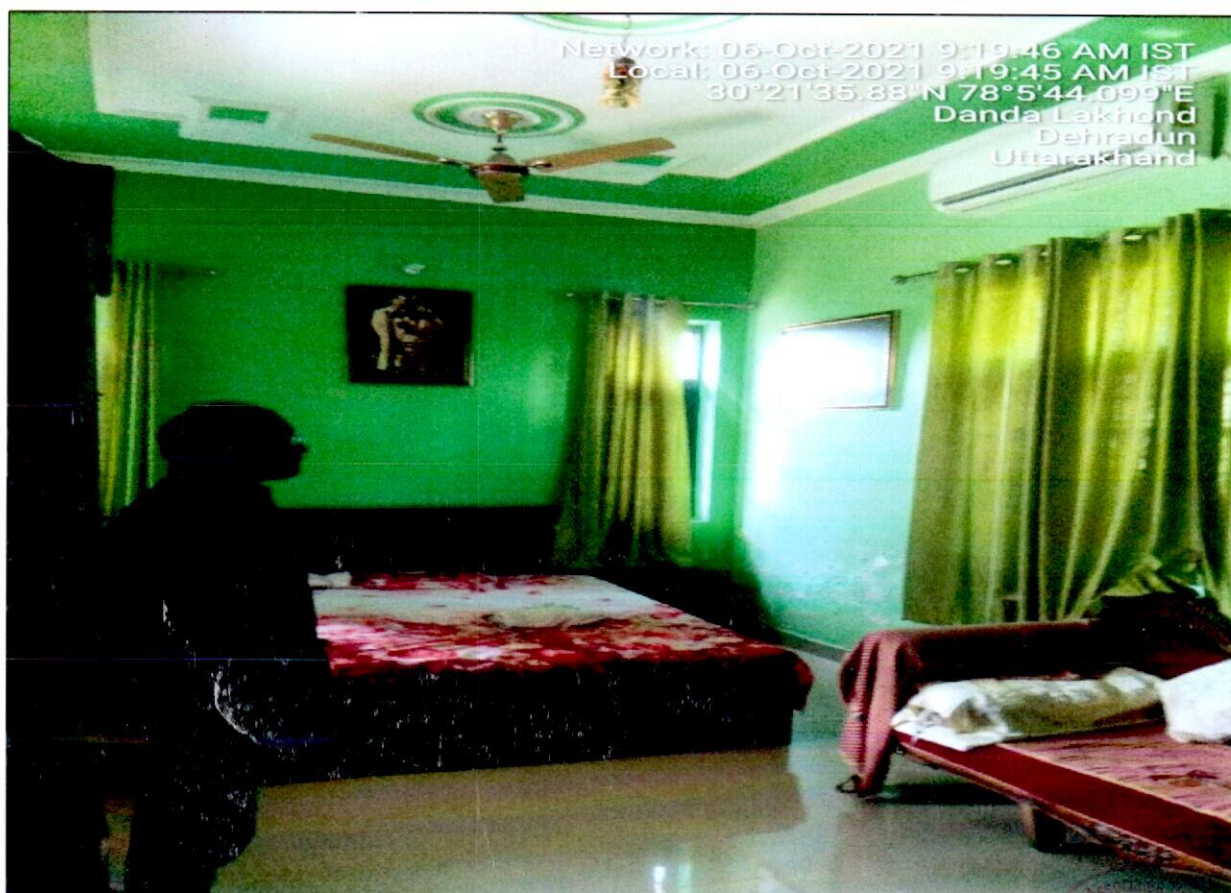
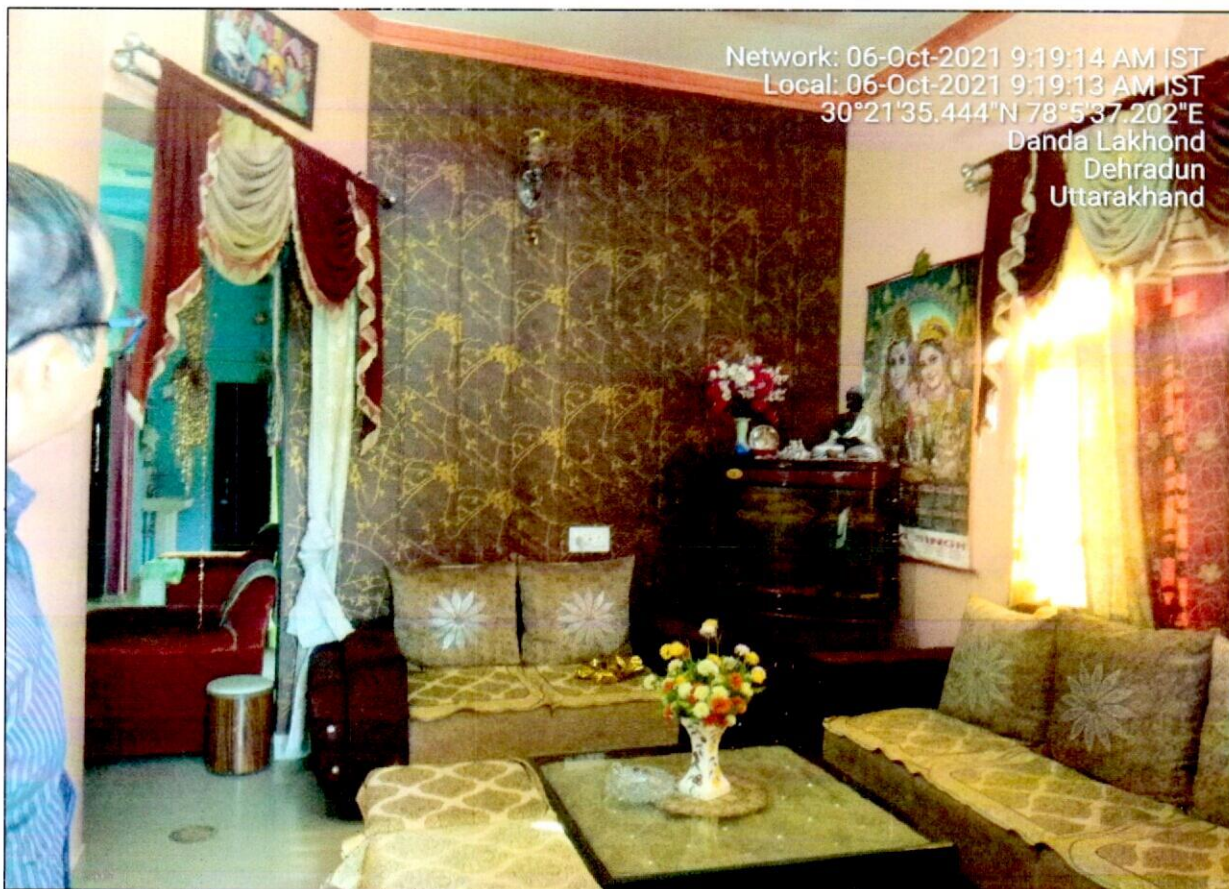

1.
