M/S.Prasad Heritage Projects(P) Ltd, Ram Ghat Road, Haridwar were sanctioned a term loan of Rs.47.00 lacs on 18.8.01 which was subsequently on the request of the request of the company dated 27.8.01, has been enhanced to Rs.50.00 lacs on 29.9.01. The sanction advice was communicated to the company on 12.10.01. The loan was sanctioned for the following purposes:-
