As per the approved map provided to us, it is allowed to construct four floors i.e. Lower ground-1, Lower Ground-2, Ground & First floor and we have considered the same for valuation purposes

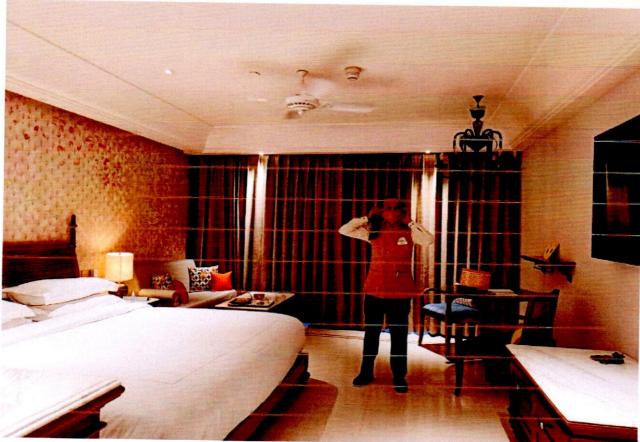
