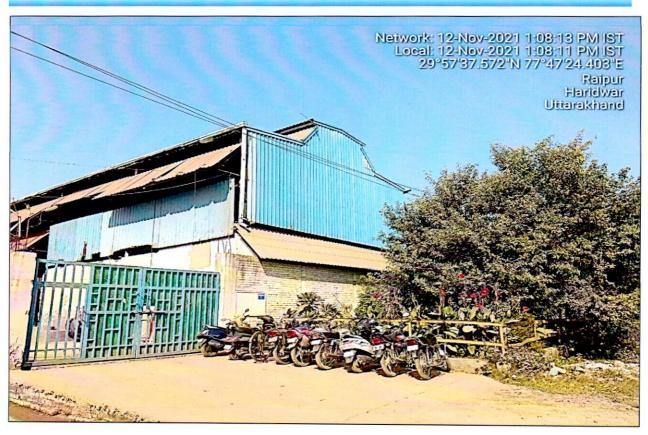
ANNEXURE: III - GOOGLE MAP LOCATION

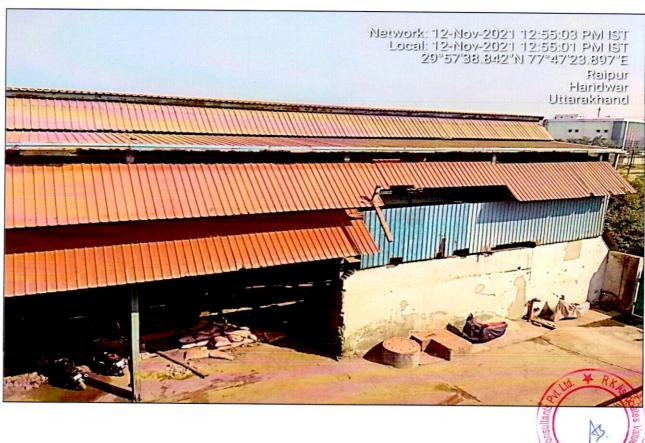






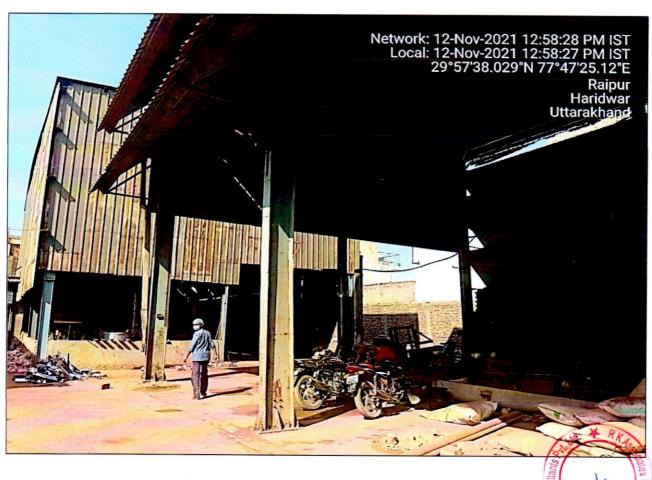
