I hereby grant permission for the occupation of the said buildings, after considering NOC from fire safety issued by Director, Fire Services, Haryana, Panchkula, Environment Clearance issued by State Environment Impact Assessment Authority, Haryana, Structure Stability Certificate given by Divyesh Anubhai Mishra, M.E. (Structure), Public Health Functional reports received from Superintending Engineer (HII), HUDA, Panchkula & Chief Engineer-I, HUDA, Panchkula & Certificate of Registration of Lift issued by Inspector of Lifts-cum-Executive Engineer, Technical Inspectorate, Haryana and after charging the commission charges amount of ₹ 23,06,713/- for the variations vis-a-vis approved building plans with following conditions:-

- The building shall be used for the purposes for which the occupation certificate is being granted and in accordance with the uses defined in the approved Zoning Regulations/Zoning Plan and terms and conditions of the licence.
- That you shall abide by the provisions of Haryana Apartment Ownership Act, 1963 and Rules framed thereunder. All the flats for which occupation certificate is being granted shall have to be compulsorily registered and a deed of declaration will have to be filed by you within the time schedule as prescribed under the Haryana Apartment Ownership Act 1963. Failure to do so shall invite legal proceedings under the statute.
- That you shall apply for the connection for disposal of sewerage, drainage & water supply from HUDA as and when the services are made available; within 15 days from its availability. You shall also maintain the internal services to the satisfaction of the Director till the colony is handed over after granting final completion.
- That you shall be fully responsible for supply of water, disposal of sewerage and storm water of your colony till these services are made available by HUDA/State Government as per their scheme.
- That in case some additional structures are required to be constructed as decided by HUDA at later stage, the same will be binding upon you.
- That you shall maintain roof top rain water harvesting system properly and keep it operational all the time as per the provisions of Haryana Building Code, 2017.
- The basements and still shall be used as per provisions of approved zoning plan and building plans.

8. That the outer facade of the buildings shall not be used for the purposes of advertisement and placement of hoardings.
9. That you shall neither erect nor allow the erection of any Communication and Transmission Tower on top of the building blocks.
10. That you shall comply with all the stipulations mentioned in the Environment Clearance issued by State Environment Impact Assessment Authority, Haryana vide No. SEIAA/HR/2013/607 dated 04.08.2013.
11. That you shall comply with all conditions laid down in the Memo. No. DFS/FA/2017/628/58850 dated 21.07.2017 of the Director, Fire Services, Haryana, Panchkula with regard to fire safety measures.
12. You shall comply with all the conditions laid down in Form-B issued by Inspector of District Executive Engineer, Electrical Inspectorate, Haryana, HUDA Primary School Building, Block-C-2, Sector-104-F, Gurugram.
13. The day E Night marking shall be maintained and operated as per provision of International Civil Aviation Organization (ICAO) standard.
14. That you shall use Light-Emitting Diode lamps (LED) in the building as well as street lighting.
15. That you shall impose a condition in the allotment/possession letter that the allottee shall use Light-Emitting Diode lamps (LED) for interior lighting, so as to conserve energy.
16. That you shall apply for connection of Electricity within 78 days from the date of issuance of occupation certificate and shall submit the proof of submission thereof to this office. In case the electricity is supplied through Generators then the tariff charges should not exceed the tariff being charged by DISBYN.
17. That provision of parking shall be made within the area demarcated/designated for parking in the colony and no vehicle shall be allowed to park outside the premises.
18. That you shall get the offense of delay in allotment of EWS units compounded as per policy dated 12.08.2013.
19. That you shall construct and obtain the occupation certificate for the commensurate number of EWS units upto 22.06.2020 (if any additional occupation certificate is also obtained by you before 22.06.2020, you will require to construct and obtain the occupation certificate for commensurate number of EWS units for those additional main dwelling unit also). If you fail to comply with the same, no further occupation certificate for the main dwelling units of DLF City Phase-X shall be granted till occupation certificate for commensurate number of EWS unit is obtained.
20. Any violation of the above said conditions shall render this occupation certificate null and void.
