The subject property is being used as a combination of two properties as a single unit</p>		

under the same owner name.

The subject property is located in the midst of developing notified industrial area known as HSIIDC (Haryana State Industrial and Infrastructure Development Corporation) located near the Hisar Bypass Road, adjacent to railway line and can be easily approached through internal road known as Circular road.

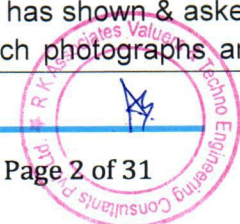

Integrity and Fairness

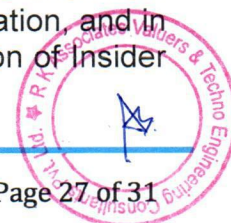
1. A valuer shall, in the conduct of his/its business, follow high standards of integrity and fairness in all his/its dealings with his/its clients and other valuers.

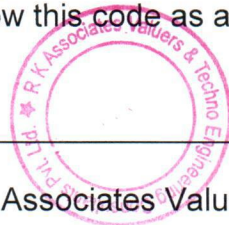

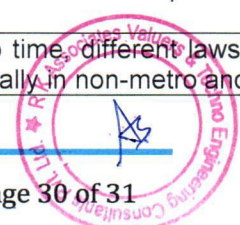

1.
