

#### Section 1 - Executive Summary


**Update For The Month:** SEW began works in parts on 7 out of 11.34 km, on 16-Dec-20 – the value of which is estimated at **~INR 67 Cr** as per preliminary estimates. As on Nov-21, it is expected that at Beldanga Junction (km 179+410), 0.45 km of new work-front will be handed over by NHAI by mid Dec '21. Presently, 1.84 km of length has been made available out of 2.34 for work. During Nov-21 the value of work done was **~INR 0.37 Cr**. During the same period, towards O&M works – a total of INR **1.01 Cr** of payment requests for 15 vendors were made of which **INR 0.96 Cr** were recommended. Towards Construction works – a total of **INR 1.44 Cr** of payment requests for 42 vendors were made of which **INR 1.44 Cr** was recommended.



#### Section 3 - Work Progress

The progress achieved by the EPC contractor is represented in the S Curve below. ~INR 293 Cr was originally estimated to complete the entire ~77 km of the project. However, owing of the reduced encumbrance-free RoW handed over the value of works was reduced to ~INR 101 Cr for the available work-front – executed in Q3 H2FY22 as on date





Access Road to ROB 2 A2 Side





No.	Critical Issue	Description			
1	ROB 2 Approaches: Diversion	Delay in implementation of diversion plan for ROB 2 approach works is a major concern since PCOD as it involves construction of a new Level Crossing for vehicular movement over the railway track. Since the utilities have ben shifted, the concessionaire needs to communicate to NHAI for handover of remaining land so that construction activities can commence.			
2	Land Handing Over	Status of land handed over, encumbrance-free, is enclosed in Annexure - 1. It is advised that the concessionaire communicate regularly with NHAI for handover of remaining land for construction activities to commence.			
3	O&M – Periodic Maintenance	Due to over loaded (70 to 80 MT category) transport vehicles plying, the surface on RHS is visibly damaged at various locations. The concessionaire is thereby forced to carry out the BC repairs for over 25 km length for on varying widths of 3 to 4 m. Due to the movement of overloaded vehicles till mid of 2021 since PCOD, additional pavement maintenance costs have arisen and are likely to increase further on RHS.			
4	O&M - Emergency Services Staff	Dedicated Route Patrolling Officer has been mobilized. Additional drivers and operators for night shift have been hired - RPO Van, Tow Truck/Crane and Ambulance.


