

Brief description of the property

This opinion on Valuation is prepared for the independent builder floor situated at the aforesaid address having total area admeasuring 170.15 sq.mtr. (1830.85 sq.ft.) as per the TIR provided to us by the bank.

The said property is an independent builder floor located in the second floor of a G+2 building. The property constitutes of 3 Bedroom, 1Hall, 1 Kitchen and 1 Servant quarter.

The property is currently vacant and no utility bills have been provided to us by the owner, since electric meter is not installed in the subject property.

The subject property is located in Wave city of Ghaziabad and is around 3 K.M. far from Delhi Meerut Express way.

Most of the civic amenities are around 5 K.M. to 6 K.M. from the said property.
