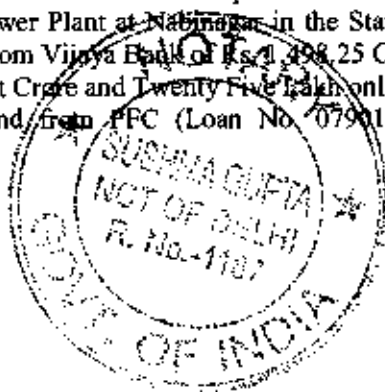

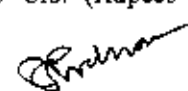

Declaration in the matter of mortgage of immovable properties comprising of 48.2625+137.392 acre (approx) land (in addition to existing mortgaged land adm. 1151.489 acres), mortgaged by deposit of title deeds in respect of immovable properties of 4x250 mw coal based Nabinagar Thermal Power Project at Nabinagar in Aurangabad district of Bihar to secure by first charge on pari-passu basis the rupee term loan of Rs. 4099.85 crore (Rupees Four Thousand Ninety Nine Crore and Eighty Five Lakhs Only), sanctioned by Power Finance Corporation ("PFC") and Rs.1600.00 Crores (Rupees Sixteen Hundred Crore Only) sanctioned by Vijaya Bank (Rs. 1,498.25 Crore borrowed and availed till date from Vijaya Bank), by and on behalf of Bhartiya Rail Bijlee Company Limited ("BRBCL")

I, Sivakumar Chilakapati, son of Chilakapati Ramamurthy, aged about 54 Years, Indian inhabitant at presently residing at Flat No. 304, Pramila Apartments, Secunderabad, Hyderabad, Telangana hereby solemnly declare and say as follows:-

1. I, Sivakumar Chilakapati of **BHARTIYA RAIL BIJLEE COMPANY LIMITED**, a company incorporated under Companies Act, 1956 having its Registered Office at NTPC Bhawan, Core 7, Scope Complex, Lodhi Road, New Delhi - 110003, India and Project office at Jain Bunglow, Dalmia Nagar Dist. Rohtas, Bihar Pin - 812 305 (hereinafter referred to the "Borrower" or "BRBCL" or "the Company") and I, am duly authorized by the Board of Directors of the Company, vide Board Resolution passed at the 62nd meeting of the Board of Directors held on 21.12.2015, to make this declaration for and on behalf of the Company.
2. I state on behalf of the Company, that the Company has a valid right, title & interest and is seized and possessed of or otherwise well and sufficiently entitled to all those pieces or parcels of lands, hereditaments and premises situated in Sub Division & District Aurangabad, State of Bihar, admeasuring 48.2625+137.392 acres of land more particularly described in Schedule I hereunder written together with all buildings, erections, godowns, and constructions of every description which are standing, erected or attached or shall at any time hereafter during the continuance of the security hereby constituted be erected and standing or attached to the aforesaid lands and premises or any part thereof and all rights to use common areas and facilities and incidentals attached thereto, together with all trees, fences, hedges, ditches, ways, sewers, drains, waters, watercourses, liberties, privileges, easements and appurtenances whatsoever to the said lands, hereditaments or premises or any part thereof whether presently in existence or in the future belonging to or in any way appurtenant thereto or usually held, occupied or enjoyed therewith or expected to belong or be appurtenant thereto AND ALL the estate, right, title, interest, property, claim and demand whatsoever of the Company into and upon the same which description shall include all properties of the above description whether presently in existence, constructed or acquired hereafter (the "**Immovable Properties**").

 - (i) I state on behalf of the Company that the Company, has availed financial assistance by way of Term Loan for the implementation and setting up of 1000 MW Coal fired Thermal Power Plant at Nabinagar in the State of Bihar [hereinafter referred to as "**the Project**"] from Vijaya Bank of Rs. 1,498.25 Crore (Rupees One Thousand Four Hundred Ninety Eight Crore and Twenty Five Lakh only) [hereinafter referred to as "Vijaya Bank Facility" and from PFC (Loan No. 07901001) of Rs. 4100.85 Crs. (Rupees Four

Thousand Ninty Nine Crores Only) [hereinafter referred to as "**PFC Facility**" aggregating to 5,599.1 Crore (Rupees Five Thousand Five Hundred Ninty Nine Crore and One Lakh only).

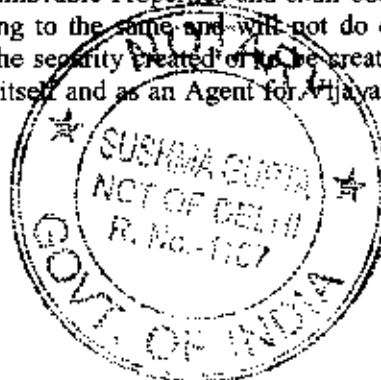
- (ii) I further state on behalf of the Company that the Company has entered into Loan Agreements with PFC on March 10, 2010 and further amended on, March 29, 2016 & June 21, 2016 (hereinafter referred to as "**PFC Facility Agreement**") and with Vijaya Bank on May 24, 2018 (hereinafter referred to as "**Vijaya Bank Facility Agreement**").
- (iii) I further state on behalf of the Company that the immovable properties of the company comprising of total land adm. 1151.489 acres of the Project land were mortgaged on pari passu basis, in favour of PFC as security for the due repayment of PFC Facility and REC Facility, together with payment of interest, additional interest in case of default, liquidated damages, premium and reimbursement of all costs, charges and expenses and other monies payable by the Company, whatsoever stipulated in or payable under the PFC Facility Agreement and Vijaya Bank Facility Agreement respectively.
- (iv) I further state on behalf of the Company that the Company has entered into amendatory Loan Agreements with PFC whereby the loan amount was enhanced by Rs. 253.25 Crore and 1598.60 Crore respectively thereby enhancing the total loan amount to Rs. 4099.85 Crore to be advanced to the Borrower by PFC and loan portion of REC was taken over by Vijaya Bank vide MoA dated 24.05.2018.
- (v) I further state on behalf of the Company that the company has offered to create a first pari-passu-charge over the additional project assets admeasuring to 48.2625+137.392 acre to secure the due repayment of loans of Rs. 4099.85 Crore & Rs. 1,498.25 Crore advanced by PFC & Vijaya Bank respectively and have deposited the title deeds and documents relating thereto the additional land admeasuring to 48.2625+137.392 acre in faour of PFC in addition to the existing mortgaged land admeasuring 1151.489 acres, thereby total of the project land mortgaged comes to 1337 acres (approx).
- (vi) I further state on behalf of the Company hereby deposited by way of actual delivery, the original documents of title, evidence, deeds and writings of the immovable properties of the company comprising of 48.2625+137.392 acres situated at project site, more particularly described in **Schedule I** hereunder written together with all buildings, erections, godowns, and constructions of every description which are standing, erected or attached or shall at any time hereafter during the continuance of the security hereby constituted be erected and standing or attached to the aforesaid lands and premises or any part thereof and all rights to use common areas and facilities and incidentals attached thereto, together with all trees, fences, hedges, ditches, ways, sewers, drains, waters, watercourses, liberties, privileges, easements and appurtenances whatsoever to the said lands, hereditaments or premises or any part thereof whether presently in existence or in the future belonging to or in anyway appurtenant thereto or usually held, occupied or enjoyed therewith or expected to belong or be appurtenant thereto AND ALL the estate, right, title, interest, property, claim and demand whatsoever of the Company into and upon the same which description shall include all properties of the above description whether presently in existence, constructed or acquired hereafter (the "**Immovable Properties**").

Immovable Properties and that the said Title Deeds, more particularly described in **Schedule II** hereof, in relation to Immovable Properties are being deposited with an intention to create an Equitable Mortgage by the deposit of title deeds with PFC (for itself and as an Agent for Vijaya Bank) are the only documents of title relating to the Immovable Property relating to the Project and are sufficient and adequate for recording title relating to Immovable Property.

4. I state on behalf of the Company that the land that forms part of the Immovable Property is outside the purview of the Urban Land (Ceiling and Regulation) Act, 1976.

 - (b) I state on behalf of the Company, that the Company has obtained the requisite consent/ no objection from the Income Tax Authorities pursuant to Section 281 of the Income Tax Act, 1961 and such other consents as are required for the mortgage of Immovable Property in favour of the PFC (for itself and as an Agent for Vijaya Bank), and agrees to submit the same, as and when demanded and by the PFC.

 - (a) I state on behalf of the Company that the Company has duly paid all rents, royalties and all public demands including provident fund dues, gratuity dues, employees state insurance dues, income tax, sales tax, corporation tax and all other taxes and revenue payable to the Government of India or to the government of any State or to any local authority (such material taxes as certified by the Company's auditors as being due and payable by the Company) and that at present there are no arrears of such dues, rents, royalties, taxes and revenue due and outstanding and that no attachments or warrants have been served on the Company in respect of sales tax, Government revenue and other taxes.
 - (b) I state on behalf of the Company that the Company shall pay all rents, rates, taxes, cesses, fees, revenue assessments, duties and other outgoings and pay other amounts due in respect of the Immovable Properties and shall observe and perform all the rules and regulations pertaining to the same and will not do or omit to do or suffer to be done anything whereby the security created or to be created on the Immovable Properties in favour of PFC (for itself and as an Agent for Vijaya Bank) be affected or prejudiced in any manner.



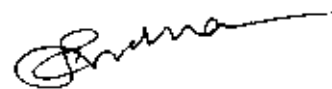
