

# AGREEMENT FOR SUPPLY OF ELECTRICITY

t (hereinafter referred to as the "Agreement") dated this, the 14th day of December (hereinger referred to as the "Execution Date"), is executed at New Delhi.

#### BY AND BETWEEN

JK Tyre & Industries Limited, a company within the meaning of the Companies Act, 2013, having its registered office at Jaykaygram, PO Tyre Factory, Kankroli – 313342, Rajasthan, and having one of its tyre manufacturing facilities at Kankroli, Rajasthan, (hereinafter referred to as JKT which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns) of the First Part;

#### AND

Zorya Distributed Power Services Private Limited, a company within the meaning of the Companies Act, 2013, having its registered office at 138, Ansal Chamber-II, Bhikaji Cama Place, New Delhi – 110066, and corporate office at Commercial Block – 1, Zone - 6, DLF Phase – V, Gurugram – 122009, Haryana (hereinafter referred to as "ZDPSPL" which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns) of the Second Part.

"JKT" and "ZDPSPL" are individually referred to be as the "Party" and collectively, referred to be as the "Parties".

#### **WHEREAS**

- A. ZDPSPL has represented to JKT that ZDPSPL shall design, finance, build and operate a 3 mega-watt peak (MWp) ground mounted solar power plant at JKT's tyre manufacturing facility at Kankroli, Rajasthan (hereinafter such solar power plant referred to as the "Power Plant" and the area identified for the construction of such solar power plant within JKT's tyre manufacturing facility at Kankroli, Rajasthan is to be referred as the "Site"), and shall supply the entire electricity generated to JKT for consumption at its facility;
- B. ZDPSPL unconditionally and categorically declares and represents to JKT that it has complied or shall comply, with and conform to applicable open access regulations, if applicable, for supply of electricity pursuant to this Agreement, and should any further requirement of any other permission / approval becomes necessary in future for whatever reason, ZDPSPL shall take all steps to comply with the same at no cost to JKT and will undertake to ensure uninterrupted power supply from the Power plant for entire period of this Agreement.
- C. ZDPSPL represents to JKT that the expected life of the Power Plant shall be twenty-five (25) years from the date of commissioning of the Power Plant.
- D. JKT has an existing connection from the local distribution licensee, AVVNL, from which it currently sources electricity for its tyre manufacturing facility in Rajasthan. JKT now wishes to procure a certain portion of its electricity requirement from the Power Plant;
