5. Brief description of the property

This opinion on Valuation report is prepared for the industrial property situated at the aforesaid address having total land area admeasuring 149307 sq.mtr.as per the order for the change of land use from Agriculture to Non Agricultural provided to us.

We have adopted the Land area as 1,43,606 sq.mtr. Which is the only converted land and as per the client. Client is only sure of the converted land area under their rightful possession at present.

It has a covered area of 32,494 sq.mtr (3,49,762.17 sq.ft) as per the Building Sheet provided to us by the Client and the same is randomly verified at the site.

The subject Property is located in village-Mahagaon, District-Palghar of Maharashtra. The subject property is located in the midst of rural area of Mahagaon. This property is around 150 mtr. from Baisar-Mahagaon Road.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Even in old locations of towns, small cities & districts where property number is either not assigned or not displayed on the properties clearly and also due to the presence of multiple/parallel departments due to which ownership/ rights/ illegal possession/ encroachment issues are rampant across India and due to these limitations at many occasions it becomes tough to identify the property with 100% surety from the available documents, information & site whereabouts and thus chances of error, misrepresentation by the borrower and margin of chances of error always persists in such cases. - 26.
