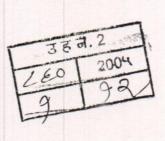

Shri CHETAN GOVIND SHAH, aged about 29 years, Indian Inhabitant, residing at Asha Vihar Building, Flat No.A/105, Hendre-Pada Road, Post Kulgaon, Badlapur (West), Dist. Thane, Pin - 421 503, hereinafter called as "the PURCHASER" (which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to include his heirs, executors, administrators and assigns) of the Other Part.

WHEREAS by an Agreement for Sale dated 27/05/'96 and which is duly registered under serial No.ULH-2 / 1473/'96 made between one M/s. L. V. PATEL & CO. (a partnership firm of Ghatkopar, Mumbai) of the One Part and the Vendor herein of the Other Part, the said M/s. L. V. PATEL & CO. agreed to sell and transfer and the Vendor aforesaid agreed to purchase and had thus acquired a residential premises being a Flat bearing No.101 area admeasuring 550 Sq. feet equal to 51.10 Sq. metre built-up on the First floor of the building known as Wing "A" of "ASHA - VIHAR BUILDING NO.1" situated at revenue Village Kuigaon, Badlapur (West), Taluka Ambarnath, Dist. Thane (hereinafter for brevity's sake referred to as "the said flat") together with the permanent and absolute right of use and occupation of the said Flat No.A/101;

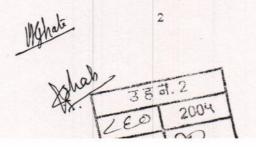
AND WHEREAS the Vendor had in terms of the said Agreement for Sale dated 27/05/'96 paid to the said M/s. L. V. PATEL & CO., the entire consideration mentioned in clause No.02 thereof;

AND WHEREAS the Vendor is in possession of the said Flat No.A/101;

AND WHEREAS the Vendor has agreed to sell and transfer to the Purchaser and the Purchaser has agreed to purchase and acquire all rights, title and interest of the Vendor in the said flat together with the permanent and absolute right of use and occupation of the said flat with the benefit of the deposit paid by the Vendor to the developers for formation of the Co-operative Housing Society;

NOW THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. The Vendor shall sell and the Purchaser shall





purchase and acquire the said Flat No.101 on the First floor of the building known as Wing "A" of "ASHA - VIHAR BUILDING No.1" together with the permanent and absolute fight of use and occupation of the said flat and together with the benefit in the said deposit for a lumpsum price of Rs.4,05,000/-(Rupees Four Lakh Five Thousand Only).

- 2. The Purchaser has paid to the Vendor on or before the execution of these presents a sum of Rs.5,000/-(Rupees Five Thousand Only) as earnest (receipt whereof the Vendor doth hereby admits and acknowledges) and the balance of Rs.4,00,000/- (Rupees Four Lakh Only) shall be paid within a period of 45 days from the date of execution and registration hereof (Time being of the essence of contract).
- 3. The Vendor doth hereby covenant with the Purchaser that the said flat agreed to be hereby sold is not subject to any charge, claim, mortgage, lispendence, lien, litigation and the same is free from all encumbrances of any nature whatsoever and declares that he has neither received any notice of acquisition or requisition from the Government or from the local authority in respect of the said flat. The Vendor has full and absolute power to transfer and deliver possession of the Flat No.A/101 to the Purchaser.
- 4. The Vendor shall deliver vacant possession of the said flat to the Purchaser but only against payment of the said balance amount of Rs.4,00,000/- (Rupees Four Lakh Only) by the Purchaser to the Vendor as and by way of completion of the sale.
- 5. The Vendor doth hereby covenant with the Purchaser that he the Vendor has paid to the said M/s. L. V. PATEL & CO. his share of taxes and outgoings upto date in respect of the said flat and that if any amount is due from the Vendor to the said M/s. L. V. PATEL & CO. and/or any other person or persons or authority for his share of taxes and outgoings or any amount relating to the said flat, the same shall be paid by the Vendor and if any such amount is recovered from the Purchaser relating to the said flat the same shall be made good by the Vendor to the Purchaser and the Vendor doth hereby agrees to indemnify the Purchaser for payment thereof.
- 6. The Vendor doth hereby further covenant with the Purchaser that the Purchaser shall on being put into possession of the said flat, quietly and peacefully possess and occupy and enjoy the said flat without any let, hindrance, denial, demand, interruption or eviction by the Vendor or any other person or persons

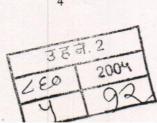




lawfully or equitably claiming through under or in trust for the Vendor.

- 7. That the Purchaser shall on completion of the sale be entitled to have and hold the possession, occupation and use of the said flat and the Purchaser shall hold the same unto and to the use and benefit of the Purchaser, his heirs, successors and assigns forever without any claim, charge, right, interest, demand of light of the Vendor or any person or persons claiming through or under him or in trust for him subject to payment by the Purchaser of all taxes, assessments, charges, duties or calls made by the said Society, Government, revenue or local authorities hereafter in respect of the said flat.

The Purchaser doth hereby covenant with the Vendor that save and except as aforesaid the Purchaser shall from the date of possession pay his share of taxes and outgoings as mentioned in the said Agreement and shall also become a member of the Co-operative Housing Society or any another incorporated body to be formed by all the flat-owners of the said building and shall carry out the terms and conditions of the said agreement and also abide by the rules and regulations of the said Society.
- 9. That the Purchaser doth hereby covenant with the Vendor that he shall abide by the rules and regulations and the bye-laws of the Society (that may be formed) on admission as a member thereof and that he agrees and undertakes to pay and discharge all calls demands, contributions and dues which the said Society may hereafter make in respect of the said flat.
- 10. The Vendor hereby further covenant with the Purchaser that the Vendor shall from time to time and at all times whenever called upon by the Purchaser or his Advocate or Attorneys do and execute or cause to be done and executed all such acts, deeds and things whatsoever for more perfectly securing the interest of the Purchaser in the said flat agreed to be hereby sold unto and to the use of the Purchaser as shall or may be reasonably required but at the cost of the Purchaser.
- 11. The said Agreement dated 27/05/'96 and all other relevant papers and receipts for payments made by the Vendor shall be delivered by him to the Purchaser at the time of completion of the sale or earlier if it is required for obtaining housing loan.
- 12. Save and except as aforesaid all the terms and conditions of the said Agreement dated 27/05/'96 shall be binding on the Purchaser as if all the terms and conditions were bodily incorporated in this Agreement.







13. All expenses such as Stamp Duty, Registration fees and other out of pocket expenses incidental to this transaction are borne and paid by the Purchaser.

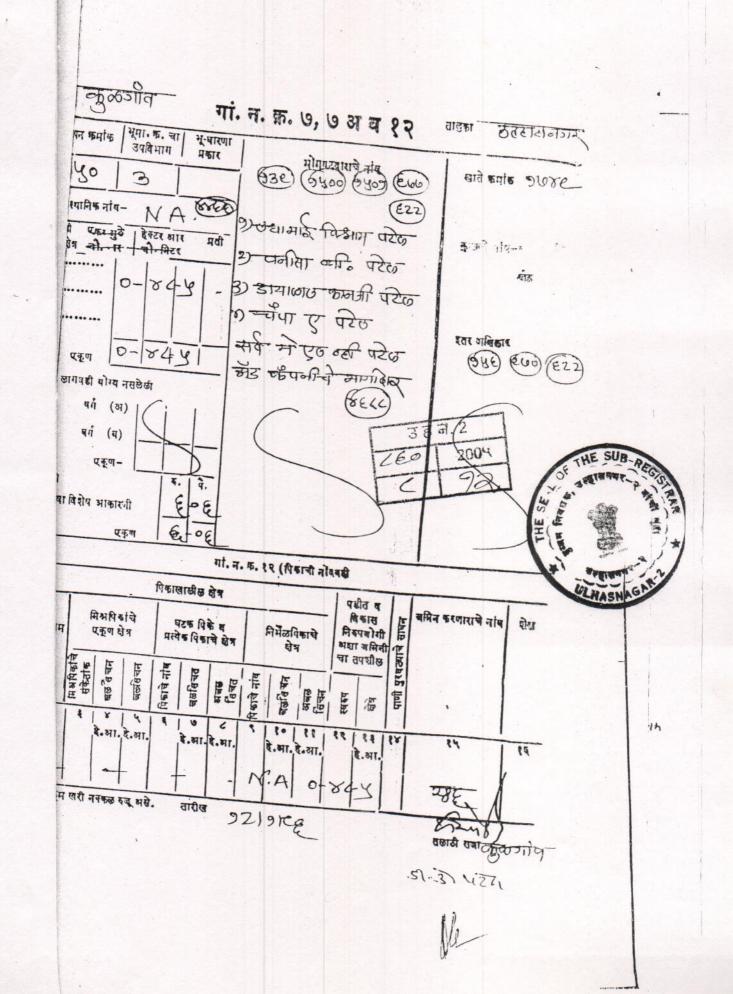

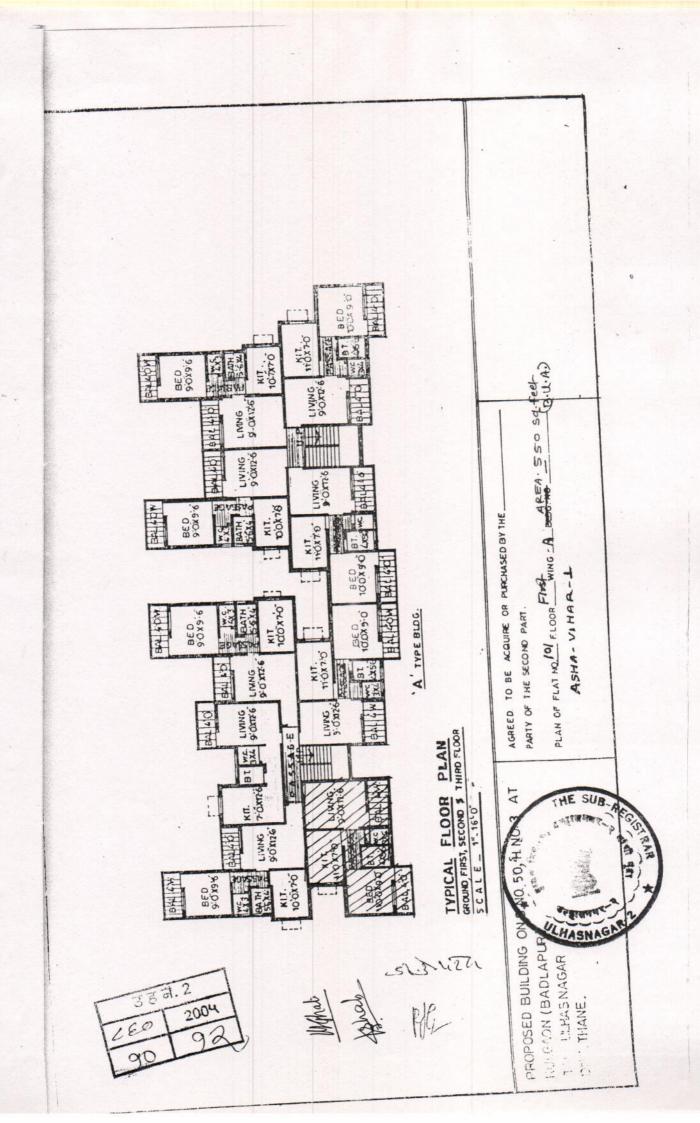
