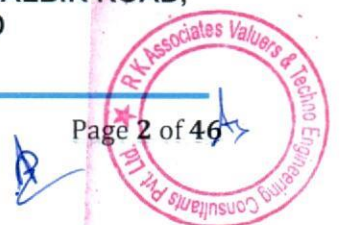

The said property is located on the first floor of a S+4 building known as 'Ganga Apartment'.

The subject property is located in Dalanwala region of Dehradun which is a residential area and is around 70 mtrs from Balbir road.

Relevant civic amenities are available within 1 K.M. radius of the subject property.

The identification of the property is done with the help of purchaser Mr. Harneet Singh and name plate is displayed at the entrance of the property; valuation of the property is done on as-is-where-is basis.

Integrity and Fairness

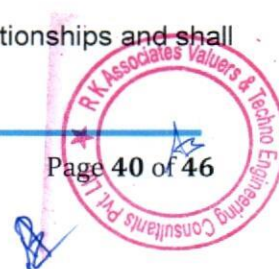
1. A valuer shall, in the conduct of his/its business, follow high standards of integrity and fairness in all his/its dealings with his/its clients and other valuers.

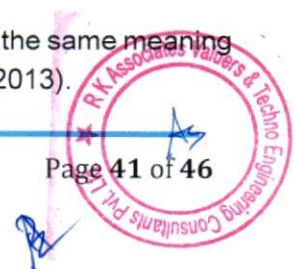

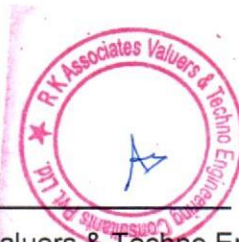

20.
