We have done the valuation only on the basis of the details mentioned in the document provided to us by the client. The value given in the report for the subject property is as on dated 01/03/2021 as per requirement of the client.				

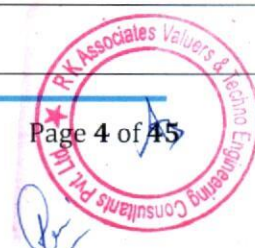
The subject property was locked at the time of survey and was not surveyed from inside, the valuation is done assuming the internal health of the property to be fine. Any deviation will affect the value of the property. Also the identification of the property is done by our survey on the basis of documents provided by the client without any representative as no one was available. Also as per the verbal information provided to us by the client the subject flat is closed since very long and no taxes and other bills have been paid so the electricity and the water connection might be disconnected. The subject property is a 3 BHK property as per the documents provided to us.

The Subject property can be approached through Block road about 40 ft. wide whereas the nearest Main road to the Property is Main Mathura Road which is around 350 mtr. from subject Property.

In case of discrepancy in the address mentioned in the property documents and the property shown to us at the site due to change in zoning or administrative level at the site or client misled the valuer by providing the fabricated document, the valuation should be considered of the property shown to us at the site of which the photographs are also attached. Our responsibility will be only related to the valuation of the property shown to us on the site and not regarding matching from the documents or searching the property from our own. Banker/ Client to verify from district administration/ tehsil level the identification of the property if it is the same matching with the document pledged.

This report only contains general assessment & opinion on the Guideline Value and the indicative & estimated Market Value of the property of which Bank/ customer asked us to conduct the Valuation for the property found on as-is-where basis as shown on the site by the Bank/ customer of which photographs is also attached with the report. No legal aspects in terms of ownership or any other legal aspect is taken into consideration. Due care has been taken while doing valuation assessment, but it doesn't contain any due-diligence or audit or verification of any kind other than the valuation computation of the property shown to us on the site.
