To receive, compensation if the said property is required by Govt to sign, verify, present, parse all kinds of applications, suits, appeals, reviews, revisions, etc in all courts and before concerned from the original to appellate jurisdiction.

To appoint further attorney, valvy, pleader, for the above purpose or purposes to compromise withdraw them such proceedings, suits, appeals, applications, refer the matter to the commission, Arbitrator for decision, deposit diet money and get it back and to give statements.

To receive, realize and tender receipt; thereafter of any due demands due to me in all respects of the above said property to get the deposit from the courts, decimal amount costs and other dues receive and realize from the Govt treasury and tender receipt thereof and also to get the record voucher of stamp from the Govt treasury and to get the voucher of compensation encashed.

To apply for and obtain No Objection Certificate from the competent authority.

To apply for house tax, water and electric connection, and to apply for quota of cement, bricks, and other building materials, etc. generally to do acts and perform all such such acts, deeds and things thought fit and proper by the said attorney for management and control of the above property, which are not even specifically mentioned in this deed.

I do hereby ratify and confirm that all such acts, deeds and things done by the said attorney shall be binding on me in all respects.
