

I, have investigated the title of M/S Nagarjuna Fertilisers and Chemicals Ltd, Kakinada relating to the survey number and various extents of property covered under the awards enlisted and detailed in the list of document numbers, 1 to 31 supra in the tabular and submit as under.

As can be seen from the awards covered under list document numbers 1-31 supra, the same are acquired by Land Acquisition Officer cum Revenue Divisional Officer, Kakinada vide his proceedings from the general public and in their turn are said to have allotted the schedule extents to the proposed borrower/mortgagor company, NFCL for establishment and setting-up of its factory by delivering possession of the acquired extents through its subordinate officers at the ground level in the department of Revenue. The awards do contain acknowledgment from the then responsible officer of proposed borrower company, NFCL., Kakinada acknowledging possession of acquired extents of property unto their company. A.P.Industrial and Infrastructural Corporation Ltd., is also a vehicle of government of Andhra Pradesh which is holding the land bank after acquisition of landed properties from the general public. There were gazette publications to that effect having been published by District Collector, East Godavari District of Andhra Pradesh, Kakinada under its nose according sanction to such allotments by the government of Andhra Pradesh through its circulars, which are made part and parcel of the awards covered under list document numbers, 1-31 discussed supra.

The schedule of properties is situated in erstwhile Suryaraopeta Village of Kakinada and some properties have fallen within the limits of Kakinada Rural Mandal and Kakinada Urban Mandal and Kakinada Muncipal Corporation limits. The schedule of properties is explicated hereunder per classification and basing on their situation.

SEARCH CERTIFICATE

With this I am to certify that, I have made searches in respect of the above mentioned schedule of properties in the offices of Sub-Registrar of Stamps, Registrations and Assurances of Kakinada and Sarpavaram offices, Mandal Revenue offices of Kakinada Urban and Rural Mandals of erstwhile Suryaraopeta village of Kakinada in addition to local Muncipal Corporation of Kakinada relating to the schedule of properties pertaining to proposed borrower/mortgagor company proposed to be mortgaged by the said NFCL Company s set-out in the encumberance certificates.

I am to further mention hereunder the lands that fall with thin the limits of Kakinada Municipal Limits, Urban area and Rural area of Suryaraopeta village of Kakinada Taluque..

I am to further state that, the awards are not communicated to the concerned Sub-Registries and there are no notings relating to the properties owned by NFCL, Kakinada. Equally all the schedule of properties are not got mutated [except to certain portions of landed property appearing in the adangals] with the local authority of Muncipal Corporation of Kakinada and local revenue offices situated in urban and rural mandals of Kakinada Taluque relating to Erstwhile Suryaraopeta village properties. As such mutations have got to be effected with the concerned revenue authorities relating to the title of proposed loanee/mortgagor company's properties detailed in the schedules. Still names of the original owners are occurring in the revenue records in respect of the properties acquisitioned from them for the benefit of proposed borrower/mortgagor.

However relating to the schedule of properties discussed supra, there are no encumbeances at all.

However NFCL premises to somewhat and some extent falls within the local limits of Indrapalem Grama Panchayath and taxes are being paid to the grama panachayath by the said company over the property it has had. Thus this shows, enjoyment of schedule property by the said company in its own right.

I may further state that, my verification of suit registers on the file of Principal Junior Civil Judge's Court and Principal Senior Civil Judge's Court and IIIrd. Additional District Court, Kakinada within whose the territorial and pecuniary jurisdictional limits the schedule of properties fall for the past 20 years and found that there are no litigations carried over the schedule of properties detailed supra.

I am submitting this report at the forwarding and placing of information pertaining to land acquisition award properties at my disposal by the proposed mortgagor company.
