

- The Investigating Officer, during the course of investigation identified the properties mentioned in the name of Sri. K Sathyanurayana Raju, represented by M/s. It is also disclosed, that the accused have purchased the properties mentioned in Annexure to this order from out of the deposits collected from the depositors.
- 6. In the circumstances stated above, the Commissioner of Police, Hyderabad/Competent Authority has requested to Government to pass an adjusterim order for attachment of the properties of Sri K. Sathyanarayana Raju, and other is of M/s. Nagarjuna Finance company Limited, Hyderabad, and M/s. Nagarjunia Construction and Engineering Company, as shown in the Annexure (Sl. Nos. 1 to 51) to this order, in order to protect the interests of the depositors. Section 3 of the party. P. Protection of Depositors of Financial Establishments Act, 1999, (Act No.17 of 1999) provides for attachment of properties of accused who defaulted in return of depositives in cash or kind after maturity or any manner agreed upon.
- 7. Government have considered the matter and after careful examination hereby pass an ad interim order, under Section 3 of A.P. Projection of Depositors of Financial Establishments Act, 1999, (Act No.17 of 1999), for attachment of the properties standing in the name of Sri K. Sathyanarayana Rajtu, and others of M/s. Nagarjuna Finance Company Limited, Hyderabad, and Nagarjuna Construction and Engineering Company, as shown in the Annexure (Sl. Nos. 1 to 31) to this order.
  - 8. The Commissioner of Police, Hyderabad/ Competent Authority is hereby directed to take necessary further action as per the said Act and Rules, in the matter,
