5. Flow of Title:

Sy. No. 1195 and 1197:

From the above said documents submitted by the Borrower, more particularly from the registered sale deed dated 25-09-1993 vide Doc. No. 2473/93 executed by T. Rami Reddy, S/o. Venkat Reddy in favour of Nagarjuna Finance Limited, Hyderabad it is observed that the said T. Rami Reddy has conveyed land to an extent of Ac 2-02 Gts., in Sy. No. 1195, Ac 1-38 Gts., in Sy. No. 1196 and Ac 2-05 Gts., in Sy. No. 1197 totally admeasuring Ac 6-05 Gts., situated at Wargal Village and Mandal, Medak District. Further it is observed that the said Nagarjuna Finance Limited subsequent to its acquiring the land admeasuring Ac 2-02 Gts., in Sy. No. 1195 and Ac 2-05 Gts., in Sy. No. 1197 totally admeasuring Ac

4-07 Gts., through registered sale deed dated 25-09-1993 vide Doc. No. 2473/93 in turn sold the said land in favour of Nagarjuna Fertilizers and Chemicals Limited through registered sale deed dated 24-11-1994 vide Doc. No. 3103/94 registered in the O/o. SRO Gajwel. Further the SRO has made a note on Page 2 of the Sale deed that one extra copy is registered along with the original sale deed. Hence both original and extra registered copy has to be collected by the Bank at the time of creation of mortgage.

But in the sale deed vide Doc. No. 2473/93 executed by T. Rami Reddy in favour of Nagarjuna Finance Limited, it is not mentioned as to how the said T. Rami Reddy has acquired the above said lands. Further, his name is also not seen/appeared in any of the pahanies submitted by the Borrower in respect of the lands forming part of in the above said survey numbers.

Further in other legal opinions where the land in Survey numbers 1194 to 1198 are conveyed in favour of the Borrower we have already clarified that the extents purchased by the Borrower in the above said survey numbers are in excess of the actual land that exists as per the recordings of the Revenue Department and we have advised the Bank to take into consideration of the original extents as recorded in the Revenue records and also the Pattedar Passbook issued in favour of the Borrower.

Our observations made with respect to above said Survey Numbers in earlier TIRs is given below for your ready reference:

Further on perusal of the other sale transactions and their link documents and the sale transactions under the present TIR, it is observed that the Borrower has acquired lands in subject survey numbers viz., 1194, 1195, 1196, 1197 and 1198 and when attitude extents of the land acquired by the Borrower were put together it is

found that the Borrower has got excess of the lands than the original extents of the land recorded in revenue records viz., pahanies, old ROR for the year 1979-80 and ROR for the year 1989-90. However, from the IB- ROR downloaded by me from the website it is observed that the original extents of the land were recorded in the sad survey numbers though the Borrower has purchased excess extents of the lands by virtue of various sale deeds and the details of which are given hereunder. As such the Bank has to take into consideration only the extent recorded in IB-ROR and Pattedar Pass Book and Title Deed issued by the Revenue Authorities in favour of the Borrower. However, the Bank shall ensure that all the sale deeds and their link documents are deposited with the Bank at the time of creation of mortgage in order to avoid anv further mortgages/litigations etc.

In view of the above said discrepancy it is advised that the land conveyed in favour of the Borrower in respect of the land admeasuring Ac 2-02 Gts., in Sy. No. 1195 and Ac 2-05 Gts., in Sy. No. 1197 totally admeasuring Ac 4-07 Gts., situated at Wargal Village and Mandal Medak District through registered sale deed dated 24-11-1994 vide Doc. No. 3103/94 shall be kept outside purview of consideration. Further, it is advised that the Bank shall collect all the sale deeds of the Borrower irrespective of the extents of the lands conveyed in the above said survey numbers viz., 1194 to 1198 in its favour through various sale transactions.

6. Conclusion and Recommendations:

Thus, with the above said observations, on the basis of documents submitted by the mortgagor I am of the opinion that the mortgagor has acquired excess extents of lands in Sy. No. 1194 to 1198 including the subject lands in Sy. No. 1195 and 1197. As such the subject lands cannot be taken into consideration while compiling the total extent of the land held by the Borrower for creation of security in Sy. Nos. 1194 to 1198 situated at Wargal Village and Mandal, Medak District.
