- 4) The Provisional No Objection Certificate is issued subject to the following conditions:
- i. All Fire Safety measures as advised above should be provided without fail.
- ii. No temporary structure such as tents or with thatched construction shall be allowed in the premises
 - 5) The builder/Management may be informed of the following Rules and Regulations:-
 - a) As per clause 13.1 of part-II of the National Building Code of India: neither granting of the NOC nor the approval of the drawings and specifications, nor inspections made by the Authority during erection of the building shall in any way relieve the owner of such building from full responsibility for carrying out the work in accordance with the requirements of the National Building Code of India".
- b) As per clause 9.3 of part-II of the National Building Code of India "the Licensed Architect/ Engineer/Structural Engineer/Supervisor/Town Planner shall be responsible for supervision of the construction and for the completion certificates. In the event of violation of the provisions of the code he shall be liable to penalties as prescribed by the Authority including cancellation of the License".
- 6) The builder may be advised that the building/Sheds should not be occupied without obtaining No Objection Certificate for occupancy from this department about the satisfactory installation of above Fire Safety measures.
