

CONVERSION CERTIFICATE

He will obtain the no objection certificate from the competent authority in this regard as per relevant laws, failing which the conversion order shall automatically stand cancelled.

(c.) The applicant /raiyat will relinquish the subject land to the Govt. if it is subsequently vested to the State under the provision of any law in force.


