	The subject property is a residential house with G+1 floor structure built on it. As per the copy of approved

map provided to us by the bank the sanctioned area of the subject property on ground and first floor is 112.07 sq.mtr. / 1206.32 sq.ft & 111.40 sq.mtr. / 1199.11 sq.ft. respectively whereas area as per physical measurement during the time of our site survey comes out to be 1834 sq.ft. & 1494 sq.ft. on Ground & First floor respectively. In such a scenario we have considered the area as per the copy of approved map (112.07 sq.mtr. / 1206.32 sq.ft & 111.40 sq.mtr. / 1199.11 sq.ft.) for the purpose of this value assessment.

During the time of our site survey we have found the building in well maintained condition as per the information gathered on the site the ground floor of the subject property was built in year 1990 with major renovation was done in year 2016 and first floor of the building was built in year 2014.

The subject property has access from Salawala Road having road width of approx. 16 feet which further connects it to New Cantt Road.

This report only contains general assessment & opinion on the Guideline Value and the indicative, estimated Market Value of the property of which Bank/ customer asked us to conduct the Valuation for the property found on as-is-where basis as shown on the site by the Bank/ customer of which photographs is also attached with the report. No legal aspects in terms of ownership or any other legal aspect is taken into consideration. Even if any such information is mentioned in the report it is only referred from the information provided for which we do not assume any responsibility. 
