GENERAL POWER OF ATTORNEY

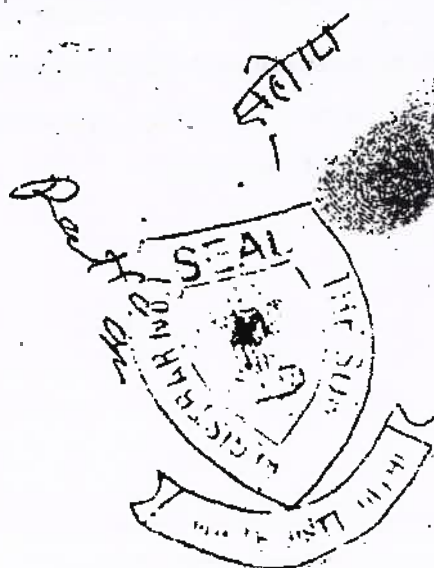

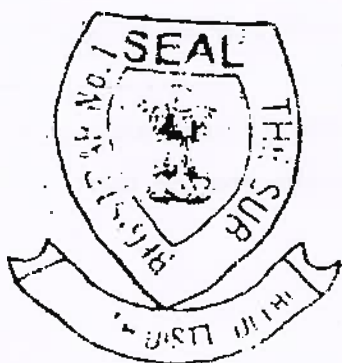
