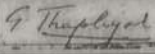

It shall come into effect after my death. I hereby revoke all former Wills and codicils, if any, made by me.

WHEREAS during my lifetime, I acquired one-third undivided share in the immovable property, in the shape of built up property and land in estate known as Cliff Hall Estate, situated at Kinraig, Mussoorie, District Dehradun, Uttarakhand;

AND WHEREAS I also have monies lying in bank account No. 32484463506 in State Bank of India, The Mall Mussoorie branch;

AND WHEREAS it is my wish and desire that after my death my one-third undivided share in the Cliff Hall Estate, Kinraig, Mussoorie, District Dehradun, Uttarakhand which share was purchased by me out of my own funds vide Sale Deed dated 24<sup>th</sup> April 1978, duly registered in Book No. 1, Volume no. 84 at pages 439 to 452 as Document No. 19 in the Office of the Joint Sub-Registrar, at Mussoorie on 16.6.1978 be given in equal shares to my said two daughters, namely Miss Nisha Thapliyal, presently aged about 44 years and Ms. Tushna Thapliyal, presently aged about 43 years, both being legal heirs and representatives as under :-

1. That to both my daughters, I hereby bequeath in equal shares to each one of them :-
  - a. My undivided one-third share in the property known as Cliff Hall Estate, which I jointly own with my Late husband's sister, Mrs Geeta Thapliyal Vitali, and my two daughters, Nisha Thapliyal and Tushna Thapliyal.
  - b. All my monies lying in my bank account no. 32484463506 in State Bank of India, The Mall Mussoorie branch;

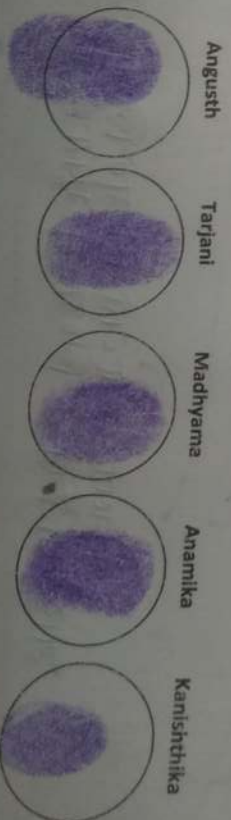
c. All or any other assets both movable and immovable that I may come to acquire during my lifetime.

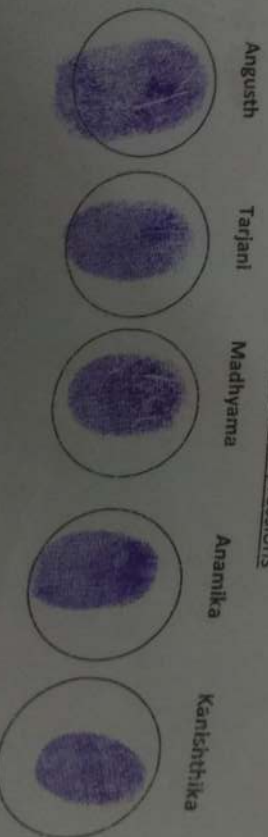

Right Hand Fingers Impressions

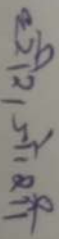

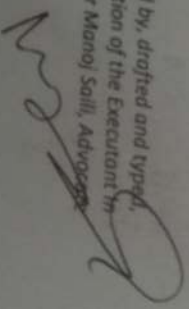
