**ENCLOSURE: III -LOCATION MAP** 





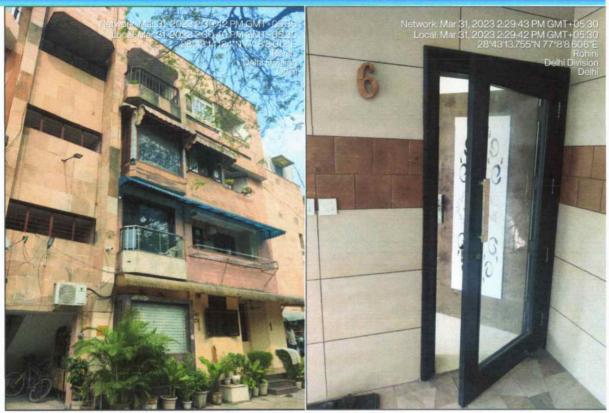
