

- Unpacking, configuring and installing the equipment specified within the quotation. This excludes modifications to the production line.
- Ensuring the equipment is performing to the specification detailed within the quotation.
- Providing appropriate operator instruction for the equipment purchased.

Vedantaram will be responsible for:

- Providing the required services such as power and air within 1 metre of the installation.
- Supply 230 volts with proper ground. Earth leakage not to exceed 3V
- Placing the equipment at the site of the installation, or as required by the Domino technical personnel.
- Facilitating the access of the Domino technical personnel to the production site.
- Carrying out any drilling on the production floor or modifications to the production line.
- Making operators available for instruction on the installation date.
- Allowing the Domino technical personnel to stop the production line for an appropriate time in order for the installation set up to be carried out.
