

CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: -

- (1) The promoter shall submit the approved service estimate and plans and fire scheme approval within 3 months from the date of grant of registration certificate.
- (ii) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government:
