- OTHER CONSUMABLES ITEMS, WATER TANK & PLUMBING MATERIAL FROM TANK TO CAGE.
- FOOD AND ACCOMODATION OF TECHNICIAN.

2). FLOOR SHOULD BE ZERO LEVEL AND ITS MANDATORY AS WITHOUT FLOOR ZERO LEVEL COMPANY WONT BE RESPONSIBLE FOR ALIGNMENT OF CAGE.

3). WIRE USED FOR CAGE WILL BE 275 GSM AND SHEET METAL PARTS WILL BE 80-100 GSM.

4). WE USE STANDARD BRANDED MOTOTS FOR EXHAUST FANS VIZ. HAVELLS , CROMPTON, ABB etc.

5). GEAR MOTOR WARRANTY WILL AS PER THE BRAND COMPANY.

6). START & END KIT WILL BE GALVANISED.

TERMS AND CONDITIONS

Taxes & Duties: - Applicable GST will be charged extra as per HSN code. Any other taxes prevailing at the time of delivery will be applicable.

Freight Charges: - Transportation charges are not included in above quoted prices.

Dispatch: - Dispatch will be commenced within 60 days from the date of necessary advance payment.

Installation of cage will be completed within 5-6 months from date of first dispatch. **(if there are no delays in payment)**

Validity: The prices quoted are valid up to 7 days from the date of quotation.

Payment Terms: - 50% Advance payment along with acceptance of order confirmation or purchase order and balance as per terms mentioned underneath.

1). Company will raise proforma invoice (PI) before dispatch of every loaded truck which is to be payable by ARCADIA EXIM within 7 days from receipt of said PI in original. Company will not be responsible for any delay in project execution if there is any delay in payment of PI and shall not bear any penalty.

3). With every PI, advance amount will be adjusted on a pro-rata basis i.e if the advance is 50% of total bill amount exclusive of GST, then payment against PI should be sent as **((Goods value+ GST) minus 50% of goods value)**

GENERAL CONDITIONS: -

1. FACILITIES AT SITE

A. CUSTOMER WILL HAVE TO PROVIDE/FURNISH FOLLOWING FACILITIES AT THE SITE, FREE OF COST TO THE SUPPLIER.

B. COVERED SPACE FOR THE STORAGE OF MATERIALS/TOOL SET ETC. TO BE KEPT UNDER LOCK AND KEY AND OPEN SPACE FOR THE STORAGE OF OTHER STRUCTURAL'S.

C. CUSTOMERS SHOULD PROVIDE 3 PHASE, 50 HZ, 415 VOLT POWER SUPPLY FOR THE SITE FABRICATION AND ERECTION WORK.

D. WATER CONNECTION TO EVERY DRINKING LINE WITH GATE VALVE TO BE PROVIDED BY THE CUSTOMER. WELDING MACHINE AND WELDING ELECTRODES, AIR COMPRESSOR (PRESSURE 12 BAR, TWO CYLINDER, 160-200 LITERS, 3 PHASES, 3 HP), CONSUMABLES LIKE NAILS, ETC. ANY MATERIAL REQUIRED TO MAKE ALTERATIONS SO THAT THE SHED IS READY FOR THE INSTALLATION OF THE EQUIPMENT SHALL BE SUPPLIED BY THE CUSTOMER.

2. MANPOWER

IT IS THE PURCHASER'S RESPONSIBILITY THAT THE NECESSARY MANPOWER IS PRESENT IN THE NECESSARY EXTENT, IN ORDER TO HELP THE INSTALLATION AND COMMISSIONING OF THE EQUIPMENT. THIS WOULD TYPICALLY BE THE MEN WHO IN THE FUTURE WILL BE USING THE EQUIPMENT.

3. DURATION OF AGREEMENT AND DATE OF COMMENCEMENT

A. THIS AGREEMENT IS VALID FOR 15 WEEKS FROM THE DATE OF QUOTATION AND IS IRREVOCABLE OTHER THAN FOR THE REASONS INCORPORATED IN THE AGREEMENT. THE AGREEMENT IS ALSO VALID FOR THE PERIOD COMMENCING FROM THE DATE OF RECEIPT OF PURCHASE ORDER ALONG WITH ADVANCE PAYMENT TO THE DATE OF THE LAST CONSIGNMENT SUPPLY AND ITS INSTALLATION.

B. ON COMPLETION OF THE INITIAL PERIOD, AS STATED ABOVE, THE AGREEMENT WILL AUTOMATICALLY STAND EXTENDED TILL COMPLETION OF THE PROJECT, UNLESS A NOTICE OF TERMINATION IS RECEIVED IN WRITING FROM THE SUPPLIER OR THE CUSTOMER, AT LEAST 1 (ONE) MONTHS PRIOR TO THE DATE OF EXPIRY OF THE AGREED PERIOD.

4. FORCE MAJEURE

A. NEITHER THE SUPPLIER NOR THE CUSTOMER SHALL BE CONSIDERED IN DEFAULT IN PERFORMANCE OF THEIR DUTIES UNDER AGREEMENTS SO LONG AS SUCH PERFORMANCE IS PREVENTED OR DELAYED FOR REASONS OF THE ACTS OF GOD, INCLUDING BUT NOT LIMITED TO, EARTHQUAKE, STORM, TEMPEST, FLOOD, TYPHOON AND CYCLONE, LIGHTNING, LANDSLIDE, FIRE OR EXPLOSION, PLAGUE OR ANY EPIDEMICS, STRIKE, RIOT, CIVIL COMMOTION, LOCK OUT, SABOTAGE, BLOCKAGE, WAR, INVASION, ACT OF FOREIGN ENEMIES, HOSTILITIES, CIVIL WAR, TRADE EMBARGO, WHICH IS BEYOND THE CONTROL OF THE SUPPLIER OR THE CUSTOMER.

B. ANY SHORTAGE OF LABOR/WORKMEN/EQUIPMENT TO EXECUTE THE PARTIES' OBLIGATION TO OPERATE THE EQUIPMENT SYSTEM CANNOT BE CONSTRUED AS FORCE MAJEURE, UNLESS CAUSED BY CIRCUMSTANCES WHICH ARE THEMSELVES FORCE MAJEURE.

C. IN THE EVENT OF FORCE MAJEURE, THE SUPPLIER SHALL USE THEIR BEST ENDEAVOR TO ARRANGE FOR EQUIPMENT TO THE CUSTOMER BY AN ALTERNATIVE MEANS.

5. NOTICE

A. ANY NOTICE UNDER THE AGREEMENT SHALL BE IN WRITING AND SHALL BE SUFFICIENTLY SERVED, SENT BY REGISTERED POST, EMAIL, TELEGRAM OR FACSIMILE ADDRESSED TO THE RESPECTIVE ADDRESSES OF THE PARTIES SET OUT ABOVE, UNLESS OTHERWISE NOTIFIED BY ANY PARTY TO THE OTHER PARTY IN WRITING.

6. WAIVER

NO FORBEARANCE, INDULGENCE OR RELAXATION BY THE SUPPLIER IN ENFORCING THE TERMS OF THE AGREEMENT SHALL IN ANY WAY AFFECT OR PREJUDICE THEIR RIGHTS UNDER THE AGREEMENT.

7. ASSIGNMENT

THE AGREEMENT SHALL NOT BE ASSIGNED BY THE CUSTOMER WITHOUT THE PRIOR WRITTEN CONSENT OF THE SUPPLIER AND SHALL BE EXCLUSIVE BETWEEN THE PARTIES.

8. TRANSFER OF LOCATION

WITHOUT PREJUDICE TO THE PROVISIONS, IN THE EVENT THE CUSTOMER DECIDES CHANGE OF LOCATION WITH ALL ITS BELONGINGS, THE CUSTOMER SHOULD INFORM THE SUPPLIER, 6 (SIX) MONTHS IN ADVANCE AND MAKE SUITABLE ARRANGEMENTS FOR THE UNINTERRUPTED CONDUCT OF THE AGREEMENT. IF SUCH TRANSFER RESULTS IN ANY DISTURBANCE TO THE CONDUCT OF THE AGREEMENT, THE SUPPLIER WILL HAVE THE RIGHT TO RECOVER FROM THE CUSTOMER ALL ITS OUTSTANDING DUES AND ALL INVESTMENTS MATCHED BY THE SUPPLIER AT THE LOCATION.

9. ENTIRE CONTRACT

A. THE AGREEMENT WITH ITS ANNEXURES SUPERCEDES ALL PRIOR AGREEMENTS AND COMMITMENTS, WHETHER ORAL OR IN WRITING BEFORE THIS DATE BETWEEN THE PARTIES CONCERNING THE SUBJECT MATTER. THE RIGHT OF EITHER PARTY TO REQUIRE STRICT PERFORMANCE WILL NOT BE AFFECTED BY ANY PREVIOUS WAIVER OR COURSE OF DEALING BETWEEN THE PARTIES.

B. THERE SHALL BE NO CONFLICT BETWEEN THIS AGREEMENT AND THE ANNEXURES, WHICH FORM AN INTEGRAL PART OF THE AGREEMENT, IN THE EVENT OF A CONFLICT, THE AGREEMENT SHALL TAKE PRECEDENCE OVER THE ANNEXURE.

C. NOTWITHSTANDING TERMINATION OF THE AGREEMENT, THE PARTIES SHALL CONTINUE TO BE BOUND BY THE PROVISIONS OF AGREEMENT, THAT REASONABLY REQUIRES SOME ACTION OR FORBEARANCE AFTER THE EXPIRATION OF THE TERMS OF THE AGREEMENT.

10. RETENTION OF TITLE

THE EQUIPMENT SHALL REMAIN THE PROPERTY OF THE SUPPLIER UNTIL PAID FOR IN FULL TO THE EXTENT THAT SUCH RETENTION OF TITLE IS VALID UNDER THE APPLICABLE LAW. THE PURCHASER SHALL AT THE REQUEST OF THE SUPPLIER ASSIST HIM IN TAKING ANY MEASURES NECESSARY TO PROTECT THE SUPPLIER'S TITLE TO THE PRODUCT IN THE COUNTRY CONCERNED.

11. SEVERABILITY

SHOULD BY PROVISION OF THE AGREEMENT BE FOUND TO BE INVALID, ILLEGAL OR OTHERWISE NOT ENFORCEABLE IN ANY COURT OF LAW, SUCH FINDINGS SHALL NOT AFFECT THE REMAINING PROVISIONS HERETO AND SHALL REMAIN BINDING ON THE PARTIES.

12. ARBITRATION

A. ALL DISPUTES, DIFFERENCES AND QUESTIONS OF INTERPRETATION OF THE PROVISIONS OF THE AGREEMENT SHALL BE REFERRED TO ARBITRATION UNDER THE PROVISIONS OF THE ARBITRATION AND CONCILIATION ACT 1996 (ACT NO 26 OF 1996), OR ANY STATUTORY MODIFICATIONS OR REENACTMENT'S THEREOF AND RULES MADE THEREUNDER FOR THE TIME BEING IN FORCE. THE VENUE OF THE ARBITRATION SHALL BE AT THE PLACE, AS DEFINED IN THE AGREEMENT.

B. EVERY EFFORT SHALL BE MADE TO CONCILiate, PRIOR TO ARBITRATION IN ACCORDANCE WITH THE ACT.

13. ORDER CONFIRMATION

AN ORDER IS A DEFINITE ORDER WHEN A SUM OF AMOUNT IS RECEIVED AGAINST ITS VALUE AS AN ADVANCE PAYMENT. ORDER CANNOT BE CANCELLED ONCE PLACED.

14. JURISDICTION AND APPLICABLE LAW

THE AGREEMENT, INCLUDING ALL MATTERS CONNECTED THEREWITH SHALL BE GOVERNED BY THE LAWS OF INDIA, FOR THE TIME BEING IN FORCE AND SHALL BE SUBJECT TO THE EXCLUSIVE JURISDICTION OF THE COURTS AT THE BARNALA DEFINED IN THE AGREEMENT.
