Special Additional Conditions:

- i. The unit shall install the approved retrofit emission control device/equipment with at least 70% Particulate matter reduction efficiency on all DG sets with capacity of 125 KVA and above or otherwise the unit shall be shift to gas based generators within the time frame prescribed in the notification No. TNPCB/Labs/DD(L)02151/2019 dated 10.06.2020 issued by TNPCB.
- ii. The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

Additional Conditions:

- 1 The unit shall operate and maintain the Air Pollution Control measures provided efficiently and continuously so as to achieve the Ambient Air quality/stack emission/ANL standards prescribed by the Board.
- 2 The unit shall conduct AAQ/SM/ANL survey through TNPCB lab periodically and furnish the report of the same to the Board.
- 3 The unit shall maintain the online VOC monitoring system properly and ensure connectivity with Care Air Centre, TNPCB for transmission of emission data without any interruption at all times.
- 4 The unit's activity shall not attract any public complaints.
- 5 The unit shall continue to develop green belt area within the premises.
