The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

Additional Conditions:

- 1 The unit shall operate and maintain the Sewage Treatment Plant efficiently and continuously for the treatment of sewage so as to bring the quality of treated sewage to satisfy the discharge standards prescribed by the Board at all times.
- 2 The unit shall operate and maintain the Effluent Treatment Plant effectively for the treatment of trade effluent so as to bring the quality of treated effluent to satisfy the discharge standards prescribed by the Board at all times.
- 3 The unit shall ensure that 0.5 KLD of treated trade effluent shall be used on land for gardening after achieving the standards prescribed by the Board and 0.5 KLD of trade effluent shall be disposed through solar evaporation pan
- 4 The unit shall maintain the impervious Solar Evaporation Pan efficiently and shall ensure that there is no seepage or overflow from the same
- 5 The unit shall ensure that under any circumstances either treated or untreated trade effluent shall not be discharged into nearby water bodies/land either directly or indirectly 6 The unit shall comply with the provisions of the Regulation of Lead Contents in Household and Decorative Paint Rules, 2016
- 7 The unit shall not manufacture Household and Decorative Paints containing lead or lead compounds (calculated as lead metal) in excess of 90 parts per million (0.009 per cent.) of the weight of the total non-volatile content of the weight of the dried paints film, as per the provisions of the Regulation of Lead Contents in Household and Decorative Paint Rules, 2016
- 8 The unit shall comply with the provisions of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.
- 9. The unit shall dispose the non-hazardous solid waste to the authorized recyclers then and there without any accumulation inside the premises.
- 10 The unit shall dispose the non-hazardous solid waste to the authorized recyclers then and there without any accumulation inside the premises.
- 11 The unit shall not "use and throwaway plastics" such as plastic sheets used for food wrapping, spreading on dining table etc, plastic plates, plastic coated tea cups, plastic tumbler, water pouches and pockets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises. Instead unit
- shall encourage use of eco friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, jute bags etc.

The unit shall maintain records of e-waste generated by them in Form-2 and make such records available for scrutiny by the TNPCB. The unit shall file annual returns in Form-3, to the TNPCB on or before the 30th day of June following the financial year.
