5. Plant and Machinery:

This is a Thermal Power generations plant of capacity $2 \times 600 \text{MW}$ – total 1200 MW and the Generations as on date of inspection is to 920 MW consequent to the power demand.

The power plant consists of:-

Boilers, Turbines, Feed pumps, Condensate pumps, Cooling water system, Water Treatment plant (Desalination plant, combined with DM Plant – Demineralization Plant), Ash handling System, Coal handling system, Fire-production system, 400KV switchyard (SF6 Gas filled), complete LT and HT switchgears, conveyer systems, Coal crusher, Coal stackers and reclimers bowl mills etc. All this units were inspected and I am to report that all are in very good working condition. Observed that this 2x600 MW thermal power plant is in good working condition and maintained well. Crushed coal stock as on date of inspection is 2 lakh MT.

Vacant Land:
