ANNEXURE

A. Conditions laid down under the Factories Act, 1948 and Odisha Factories Rules, 1950.

1. The approval accorded is subject to review at any point of time.
2. Permission accorded under provision of Section 6 of the Factories Act, 1948 and Rules framed there under cannot be construed as evidence in respect of right title interest of the plot/plots over which plans are approved.
3. Buildings, structures, chimney etc., should be constructed as per proper engineering design so that, there is no chance of failure/collapse of the same.
4. All internal roads must be concreted/black-topped and speed breakers provided at all junctions/crossroads.
5. Sufficient plantations must be developed around the boundary wall to arrest flying dust.
6. Certificate of stability in respect of building, structures, chimney etc., obtained from the competent person under Rule 3-A of the Odisha Factories Rules, 1950 shall be submitted at the time of amendment of the factory licence.
7. A Safety and Health policy is to be prepared in the prescribed manner depending on applicability as per the provisions under Rule 12-AA of the above Rules and submitted at the time of amendment of the factory licence.
8. Date of completion of construction and date from which the extension portion of the factory shall be/ has been taken into use to be reported during the amendment of licence

B. Check list of documents to be submitted for amendment of factory licence (As per applicability of Factories Act, 1948)

1. A certificate of stability in form No.1A from a competent person as required under Rule-3A of the Odisha Factories Rules, 1950.
2. A Safety and Health policy prepared in prescribed manner and signed by the Occupier & Manager affixing their photographs.
3. Safe Operation Procedure and Safe Maintenance Procedure.
4. Information regarding dangers including health hazards, if any, and measures to overcome such hazards.
5. On-Site Emergency Plan.
6. Report regarding date of completion construction & date from which it shall be/ has been taken in to use as a factory.
