2. The lessee agrees and admits its liability to pay any such sum or further sums towards premium of the demised land demanded by the Lessor consequent upon the Lessor being required to pay more towards the compensation under the provisions of the Land Acquisition Act 1894 or in pursuance of the orders of any Civil Court or any other authority enhancing the amount of compensation awarded by the Collector or other dues lawfully payable under the land acquisition proceedings or any reason whatsoever. The Lessee agrees and undertakes to reimburse the Lessor any sums or expenses incurred by the Lessor towards payment of the higher compensation or otherwise as may be assessed.

5. Notwithstanding anything contained in the lease deed, the Lessee with the previous consent in writing of the Lessor can assign or transfer his interest in the property in favour of any schedule Bank/ Financial Institution/ Life Insurance Corporation for securing loan subject to the condition that such mortgage shall not affect the rights, powers and interest of the Lessor/Govt. under this deed.
The mortgage right of the allottee shall be subsidiary to the rights, powers and interest of the Govt./ IDCO.

9. The Lessee shall pay ground rent & other statutory dues per annum to IDCO subject to revision from time to time by the concerned Revenue Authority.
10. The Lessee shall not use the property for any purpose other than the one for which the allotment has been made by the Lessor.
11. The Lessee shall not alter the name or the constitution of the Company or effect such other changes without obtaining the prior approval of the Lessor.
12. The Lessee will take possession of the property on "as it is" condition and no further demand for any development such as earth filling, raising and leveling etc. shall be entertained. Any other improvement or development is purely the responsibility of the Lessee.
13. Any Officer of the Lessors or its authorized representative shall be entitled at all reasonable times to enter upon the property to view and inspect the same whenever necessary and to ascertain the condition thereof.
14. If the dues of the Lessor hereby reserved or any part thereof, shall at any time remain arrears and unpaid for 6 Calendar months next after the date on which the same shall have become due whether the same shall have been lawfully demanded or not, or if there is a breach or non-observance by the Lessee any of the conditions and covenants herein contained and the Lessee fails to remedy the breach within 6 months of the notice in writing given by the Lessor or becomes insolvent or enters into an agreement with his creditors for composition of the said business, this agreement will be deemed to have been terminated and the Lessor may notwithstanding the waiver of any previous causes of action or rights or remedy of re-entry and without prejudice to any such right or remedy of the Lessor for recovery of rent remaining due under the lease, enter upon the said land and repossess the same as if this demised premise had not been leased out. In such case the Lessee shall pay to the Lessor as the Lessor may determine such amount by way of damages or such other charges. The amount of damage or other dues recoverable from the Lessee will be adjusted against the amount already paid by the Lessee. If after such adjustment there remains any surplus, the same only is returned to the Lessee without any interest. If after such adjustment there still remains some dues recoverable from the Lessee and if he failed to pay the same, the Lessor shall be free to take any legal action as he deems fit.

obstructions, failing which the Lessee shall be liable to pay to the Lessor damages at the rate of Rs.500/- (Rupees five hundred) only per day per acre of unauthorized use and occupation of the property besides any other liabilities provided for in this agreement or in any other law for the time being in force.

16. In case the Lessee wants to terminate this agreement of his own accord before the expiry of the period of lease, he shall give six months notice to the Lessor in that behalf and in such case the Lessee shall pay to the Lessor such amount by way of damages as may be determined by the Lessor. 17. The Lessor shall however have the discretion of permitting the Lessee to fulfill the obligation and liabilities under this agreement on such terms as the Lessor may determine and as the circumstances may warrant.
18. All outstanding and other dues payable by the Lessee shall be recoverable as public demand under the Orissa Public Demand Recovery Act-1962.
19. The Lessor shall not be responsible for any damage caused to property by natural calamities like flood, earthquake, cyclone or any other act of God and explosion, fire, riot etc.
20. The Lessor reserves the right to the mineral wealth including minor minerals on, or under the area covered by the lease and the Lessee will have the surface rights over the land. The existing outstanding customary rights of Government and the Public roads and paths through or bounding the land are reserved and are in no way affected by the lease.
21. The Lessee shall not at any time during the tenure of the lease acquire an absolute or exclusive proprietary right over the land or claim any such right whatsoever, excepting the rights to use the land in the manner prescribed herein and in case of any transfer of the land either in the usual course of inheritance or by rights of succession or by way of adverse possession and easement right of any third party as applicable against the land belonging to the Government or in case of encumbrance created either voluntarily by the Lessee or otherwise by an order of

the Civil Court, the limitations, conditions and restrictions imposed in this deed of lease will apply " Mutatis Mutandis " to any outsider claiming interest over the demised premises through the Lessee and for such purpose or otherwise in constructing any of the terms in this deed of lease, the provisions of the Government Grants Act-1895 and the provisions of the Transfer of Property Act-1882, will not be applicable.

22. The Lessee shall duly comply with the provisions of the Orissa River Pollution Act-1953 and the rules made there under as also with any condition which may from time to time be imposed by the Orissa River Board constituted under the said Act or the Central / State Pollution Control Board as regards collection, treatment and disposal or discharge of effluents or waste or otherwise howsoever and shall indemnify and keep indemnified the Lessor against the consequences of any breach or non-compliance of any such provisions or conditions as aforesaid.
23. The lessee shall obtain necessary clearances from the State Pollution Control Board for establishment of the project on the allotted land as regards collection, treatment, disposal and discharge of effluent or waste etc. within six calendar months from the date of taking over physical possession of land but before taking up any civil construction/ industrial activities and will maintain the environmental balance which might be required at the time of commission of the industry.
24. a) The lessee shall have to abide by all the applicable environment related laws/rules & regulations which exist and which may be framed by the competent authority from time to time.
b) The liquid effluent discharge of/ from the industries of the lessee shall meet OSPCB prescribed norms.
25. The lessee shall obtain clearance from Ministry of Environment and Forests, Govt. of India. The lessee shall abide by the provisions of prevailing forest laws, rules, guidelines issued by the State/Central Government from time to time.
26. The lessee shall abide by the provisions of OIIDC Act, 1980 and rules/regulations made there under, including the decision of the Board from time to time. The lessee shall also have to abide by all the terms and conditions enumerated in the lease deed bearing **No.10061107218, No.10061107219 & No.10061107220 dt.25.8.2011** executed between the Collector, Balasore and IDCO thereof along with the terms and conditions stipulated by IIAC/SLSWCA/HLCA. 27. The lessee shall obtain necessary permission from Balasore Regional Improvement Trust (BRIT) as per the provisions of ODA Act, 1982.
28. The Lessee shall not at any time cause or permit to be caused any nuisance in or upon the demised premises or anything, which shall cause unnecessary annoyance or inconvenience or disturbance to others.
29. On the expiry of the lease period or on termination of the lease due to the breach of any of the conditions of the deed or the transfer of the land or its misutilization by the Lessee, the Lessor will have right of re-entry over the land and take over the possession of the demised property and all buildings/ structures erected thereon. If the lessor does not wish to take over constructions/ additional constructions the lessee shall be bound to remove them within a period fixed by the lessor and in case the lessee fails to do so the construction shall lapse to the lessor and no compensation whatsoever on this account will be payable to the lessee by the lessor.
30. The land or any part thereof, if required by Government at any time for any public purpose, the lessor shall be entitled to resume the land or any part thereof on giving six months notice in writing and on expiry of the said period the lessor or any officer authorized by him re-enter and may take possession of the said land and all buildings/ structures etc. thereon.
31. The land covered under the agreement has been allotted for promoting the development of industries and to provide facilities to the entrepreneurs for setting up Industries for regulating the use of the factory building or otherwise. If during the tenure of this lease any relevant Act is passed or enforced by the State Legislature of Orissa, the terms and conditions of this deed will be deemed to have been automatically amended in accordance there with, and any term and condition found repugnant to such Act of the Legislature, will be treated as void and not binding on the parties.
32. That, notwithstanding anything contained in these present, the Lessor may on termination of this agreement under clause 14 and 18, transfer or lease out the property including the construction made therein, if any, to any person by private negotiation or public auction or otherwise and on such terms and conditions as the Lessor deems fit.
33. Notwithstanding any thing herein before contained, where the Lessee has become

liable to be evicted or is evicted from the said property under any of the foregoing conditions, the Lessor may in its discretion continue the allotted property in the occupation of the Lessee on payment of such fine by the Lessee as may be decided by the Lessor and in such case this agreement shall effect as if there had been no eviction of the Lessee.

34. The lessee shall make necessary provisions for peripheral development along with provisions for development of ancillary industries. These provisions shall have to be incorporated in the project report, if not provided.

35. a) That if the Lessee utilizes only a portion of the land for the purpose for which it was allotted and the Lessor is satisfied that the Lessee can continue portion of the land used by him even if the un-utilized part thereof is resumed, the Lessor may make an order declaring the transfer of the land with respect to the unutilized portion shall revert to the Lessor and direct that an amount not exceeding one fourth of such portion of the amount paid by the Lessee as cost of acquisition of land or premium for lease of land as is relative to the unutilized portion shall be forfeited to the Lessor as damage and that balance of that portion shall be refundable to the Lessee and the order so made shall be subject to the provisions of sub-clause(b) below be final and binding. In case of resumption of the whole land, one fourth of such land cost paid by the lessee shall be forfeited to the Lessor as damages and balance shall be refunded.

b) That where there is any dispute with regard to the amount relating to the unutilized portion of the land, such dispute shall be referred to the Govt. in the Industries Department and the decision of the Government thereon shall be final.

36. The Lessor reserves the right to impose any further condition and stipulations, alterations in the covenants necessary at any time to implement this agreement.

37. The Lessee shall employ the residents of the State of Orissa in all classes of services of the Lessee in preference to others, subject to their suitability and shall pay and afford reasonable facilities to such employees for their working in the factory in accordance with rules and regulations of the Lessee.

The Lessee shall train in their Factory / Workshop and Power House such number of residents of the State as may be deputed from time to time by the Govt. of Orissa.

38. All costs and expenses for preparation, execution and registration of this lease will be borne and paid by the Lessee.
39. That only the courts situated in the District of **Balasore** shall have jurisdiction to decide upon any dispute or litigation between the parties here to under this agreement.
40. Any notice required to be made or given to the Lessee here under shall be deemed to have been duly served on him if sent by the Lessor or any other officer authorized by him on his behalf through post by Registered Letter, addressed to the Lessee at the address of the said business or at the registered office of the firm and failing that, if it is affixed at the entrance of the said premises in the presence of two witnesses.
41. The Lessee shall develop & preserve Green belt in 33% of the total project area. The development of plantation shall be taken up at their own cost.
42. In case the project land (private or government or both) interspersed with forest land, the lessee shall have to allow free access to the local community till the same is alienated after obtaining due approval of the diversion proposal by the Ministry of Environment & Forest.
43. In case of Government land for felling of trees for the purpose of the project, enumeration of the number of trees shall be made and the lessee shall deposit the cost of the trees with the Government. In case of acquired private land, the lessee shall obtain necessary clearance from the local Divisional Forest Officer before felling of trees.
44. The rehabilitation site should be kept at a reasonable distance from the reserved protected forest areas and the ousters shall be provided with necessary agriculture and grazing land for the sustenance.
45. The lessee shall make all arrangements for providing opportunity to the local people to express their views in Grama Sabha meeting in the scheduled areas and public hearing made by the Pollution Control Authority.
46. The lessee agrees to facilitate participation of small and medium industries within the State for providing products and services required for the project during its construction and implementation phase as well as during operation and to promote the ancillary and downstream industries within the State. The State Government will nominate a Nodal Agency/Officer to interact with the Company for this purpose.
47. The lessee shall have only surface right over the land.

48. The lessee shall develop green belt of 33% of the total project area along Reservoir side to protect pollution and no waste water of the industry shall be released to the reservoir. The user agency shall follow the guidelines of the Pollution Control Board.
49. The lessee shall transfer the land along the State Highway to the State Government as per requirement for development of common infrastructure/ public purpose, through gift deed, if desired by Government in future.
50. Financial closure of the project should be completed within 1 (One) year from physical possession of land.
51. If construction work is not started within 9 (Nine) months, the lease will be deemed to have been cancelled at the end of 9 (Nine) month period. Further, if the land or any part of it is not utilized fully for the purpose for which it is sanctioned within a period of 3 (three) years, the same shall revert to Govt./IDCO free from all encumbrances.
52. The Lessee shall abide by the decisions of the Rehabilitation Periphery Development Advisory Committee (RPDAC) from time to time regarding rehabilitation and employment of displaced families and shall also abide by the guidelines/ direction of Government of Orissa and other appropriate authorities regarding rehabilitation of displaced families.
53. The Lessee shall take rehabilitation and resettlement programme as per Government guidelines and prevalent practice followed in the area from time to time.
54. The lessee shall make provisions for adequate soil conservation & rainwater harvesting structure therein to establish rainwater conservation & harvesting system.
55. In the event of breach of any terms & conditions of allotment/ deed stipulated herein, this deed shall be cancelled and the lessee shall be evicted from the demised property under the provision of OPP (EUO) Act, 1972 & OIIRC Act 1980.
