Subject:-Approval of revised building plans of Group Housing Colony area measuring 14.843 acres (licence no. 110 of 2011 dated 14.12.2011) in Sector-111, Gurgaon Manesar Urban Complex being developed by Vinman Construction Pvt. Ltd. and Elite Villas Pvt Ltd. in collaboration with Kashish Developers Ltd.

Reference:-Your letter dated 02.12.2012 on the subject cited above.

It is to inform you that in-principle approval for the above said revised building plan for the purpose of inviting objections has been granted with the following conditions:-

- Invite objections from the existing allottees regarding the said amendment in the building plans through an advertisement to be issued in at least three of the following daily newspapers Times of India, Hindustan times, Indian Express, The Tribune, (English) Danik Jagran, Danik Bhaskar and Hindustan (Hindi) having wide circulation, within a period of 10 days from the issuance of approval.
- The allottees may be granted 30 days time to file their objections in the office of District Town Planner, Rewari. During this 30 days period the original building plans as well as the amended building plans shall be available in the office of the colonizer as well as in the office of District Town Planner, Rewari for reference of the general public.
- The objections received, if any, shall be examined by the office of District Town Planner, Rewari and report shall be forwarded to DG,TCP, Haryana through Senior Town Planner, Gurgaon. After giving an opportunity to the colonizer to explain its position in the matter, the DG,TCP, Haryana, within a period of 90 days from the issuance of the advertisement, may decide to make amendments in the building plans, which shall be binding upon you.

A copy of the provisional revised building plan and public notice for the purpose of inviting objections are enclosed for further necessary action at the earliest under intimation to this office.
