Additional Conditions

A. Water (Prevention and Control of Pollution) Act, 1974

- 1. Industry shall operate and maintain the effluent treatment plant regularly and ensure the treated effluent quality within prescribed standards all the time. Industry shall not discharge effluent outside the premises in any circumstances. Zero discharge condition shall be maintained all the time.
- 2. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes i.e. ESP dust, fines, slag, miss roles, mill scale etc. generated.
- 3. Industry shall comply with the guidelines issued by CPCB for coal washary i.e. installation of rain guns, construction of 03 meters high boundary wall with wind breaking screen of height of 03 meters (Total 6 meters), drains with settling pits etc.
- 4. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
- 5. Industry shall comply with the provision of Hazardous and Other Wastes (Management and Trans Boundary Movement) Rules, 2016 from the Board and comply with the rule.
- 6. Industry shall submit Environment audit report audibled by reputed institution like IIT/NIT within six months.
- 7. Industry shall submit compliance report of Environment Clearance / Consent to Establishment / Consent to Operate conditions verified by third party every year.
- 8. Industry shall ensure transportation of raw materials / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall also ensure use of mechanically covered vehicles for transportation of raw materials, fuel, dust generating products before 12/07/2021.
- 9. Wide green belt of broad leaf local species shall be maintained all along the plant premises. At-least 33% area of total plant area shall be used for green belt development. As far as possible maximum area of open spaces shall be utilized for plantation purposes.
- 10. Industry shall enhance the capacity of rainwater harvesting system to increase the ground water recharge.
- 11. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.

- 12. The renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Prashant Pandey, Sr. GM (Corporate Co-ordination) of M/s MSP Steel and Power Limited, Village & P.O. Jamgaon, Tehsil Raigarh, District Raigarh (C.G.).
- 13. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.

B. Air (Prevention and Control of Pollution) Act, 1981

- 1. Industry shall operate and maintain the existing air pollution control equipments regularly and effectively so as to ensure the particulate matter emission level below 50 mg/Nm3. Emission of air pollutants Ambient air quality within the premises shall be within latest prescribed limit. Shall be ensured within the limits prescribed by Board all the time. Chhattisgarh Environment Conservation Board may further stipulate stringent particulate matter emission limit depending upon environmental conditions.
- 2. Calibration and data validation shall be come out of all CEMS and industry shall ensure availability or real time data in CPCB/CECB server.
- 3. Industry shall install CEMS in stack of induction furnace within six months.
- 4. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes i.e. ESP dust, fines, slag, miss roles, mill scale etc. generated.
- 5. Industry shall comply with the guidelines issued by CPCB for coal washary i.e. installation of rain guns, construction of 03 meters high boundary wall with wind breaking screen of height of 03 meters (Total 6 meters), drains with settling pits etc.
- 6. Industry shall submit stack and ambient air quality monitoring reports every month to the Board regularly.
- 7. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes i.e. ESP dust, fines, slag, miss roles etc. generated.
- 8. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
- 9. Industry shall use fly ash brick, fly ash blocks or fly ash based products in their construction/repairing activities.
- Industry shall obtain letter of authorization under Hazardous and Other Wastes (Management and Trans Boundary Movement) Rules, 2016 from the Board and comply with the rule.
- 11. Industry shall submit Environment audit report audibled by reputed institution like IIT/NIT within six months.

- 12. Industry shall submit compliance report of Environment Clearance conditions verified by third party every year.
- 13. Industry shall ensure transportation of raw materials / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall also ensure use of mechanically covered vehicles for transportation of raw materials, fuel, dust generating products before 12/07/2021.
- 14. Wide green belt of broad leaf local species shall be maintained all along the plant premises. At-least 33% area of total plant area shall be used for green belt development. As far as possible maximum area of open spaces shall be utilized for plantation purposes.
- 15.
