With reference to your above application, consents under section 25 of the Water (Prevention and Control of Pollution) Act, 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act, 1981 are hereby renewed for the period of two year i.e. from 07/06/2022 to 31/05/2024, subject to the fulfillment of the terms and conditions incorporated in the various water and air consent letters and subsequent renewal(s)/amendment(s) issued by the Board and additional conditions mentioned below.

Additional Conditions

A. Water (Prevention and Control of Pollution) Act, 1974

1. Industry shall operate the effluent treatment arrangement regularly and maintain them properly. Industry shall ensure treated effluent quality meets the standard prescribed by the Board. Zero discharge condition shall be maintained all the time.

- 2. Industry shall submit third party report of verification of compliance of condition mentioned in Environmental Clearance/ CTE/ CTO every year.
- 3. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes i.e. slag, fines etc. generated.
- 4. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
- 5. Industry shall comply with the provision of Hazardous and Other Wastes (Management and Trans Boundary Movement) Rules, 2016 (as amended upto date) from the Board and comply with the rule.
- 6. Industry shall use fly ash brick, fly ash blocks or fly ash based products in their construction/repairing activities.
- 7. Industry shall ensure transportation of raw materials / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall also ensure use of mechanically covered vehicles for transportation of raw materials, fuel, dust generating products before 12/07/2023.
- 8. Industry shall enhance the capacity of rainwater harvesting system to increase the ground water recharge.
- 9. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.
- 10. Extension in tree plantation shall be carried out in the open areas available within and around the plant premises in during monsoon season. Fruit bearing species like mango, tamarind, guava etc. shall be given preference in this regard.
- 11. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Prashant Pandey, Sr. Gen. Manager of M/s MSP Steel & Power Limited, Village & P.O. Jamgaon, Tehsil & District Raigarh (C.G.).
- 12. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.
- 13. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.
- 14. In case, if the capital investment is increased by such amount that the total investment exceeds the range for which renewal fees has been paid, the industry shall have to pay the difference amount of renewal fees for the corresponding block years.

15. In case, the prescribed fee payable is amended in future, the industry shall be liable to pay the difference amount for corresponding block years.

B. Air (Prevention and Control of Pollution) Act, 1981

- Industry shall operate and maintain the air pollution control equipments properly. Industry shall ensure the emission quality meets the standards prescribed by the Board. Chhattisgarh Environment Conservation Board may further stipulate stringent particulate matter emission limit depending upon environmental conditions.
- 2. Emission of gaseous and dust air pollutants shall be latest within the prescribed limits by Board all the time. Chhattisgarh Environment Conservation Board may further stipulate stringent particulate matter emission limit depending upon environmental conditions.
- 3. Industry shall operate and maintain the existing air pollution control equipments regularly and effectively so as to ensure the particulate matter emission level below 30 mg/Nm³.
- 4. Ambient air quality within the premises shall be within latest prescribed limit.
- 5. Calibration and validation of data shall be carried out of all CEMS/CAAQMS and industry shall ensure availability of real time data in CECB / CPCB server.
- 6. Industry shall submit stack and ambient air quality monitoring reports every month to the Board regularly.
- 7. Industry shall submit third party report of verification of compliance of condition mentioned in Environmental Clearance/ CTE/ CTO every year.
- 8. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes i.e. Slag, fines etc. generated.
- All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
- 10. Industry shall obtain letter of authorization under Hazardous and Other Wastes (Management and Trans Boundary Movement) Rules, 2016 (as amended upto date) from the Board and comply with the rule.
