- 30. The land in the Industrial Estate having been constructed for promoting the development of Industries and to provide facilities to the entrepreneurs for setting up Industries, for regulating the use of the factory building or otherwise. 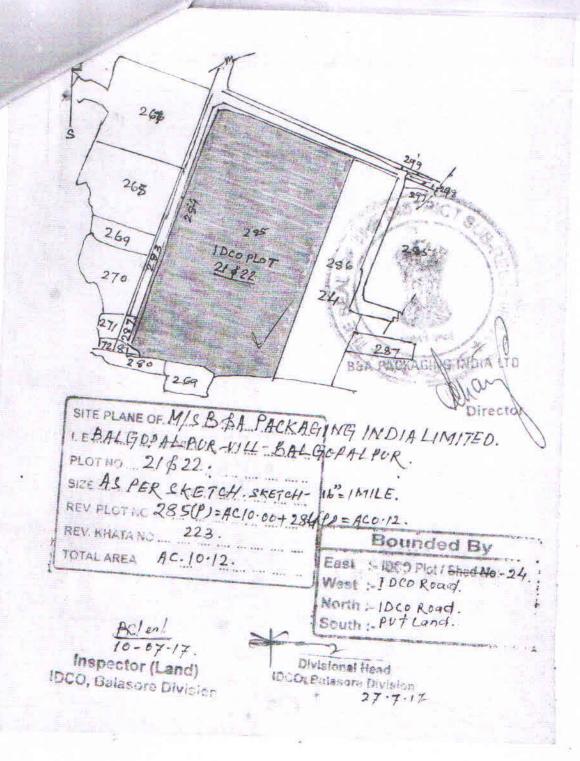
