CONSULTANCY AGREEMENT

This Consultancy Agreement ("Agreement") is executed at Gurugram on September 05, 2022 by and between:

INCUBIS CONSULTANTS (INDIA) PRIVATE LIMITED, a company registered under the Companies Act, 1956 with its registered office at 319, Pocket C, Sarita Vihar, New Delhi - 110076 and Office & Studio at 804-806, Emaar Palm Square, Sector 66, Golf Course Extension Road, Gurugram 122002, Haryana, [PAN: AAACI6764Q] (hereinafter called "Incubis" which expression shall unless repugnant to the context or meaning thereof be deemed to include its executors, administrators and assigns) of the First Part:

AND

HERITAGE HOSPITALS LIMITED, a company registered under the Companies Act, 1956 and existing under Companies Act, 2013, and having its registered office at B 27/5, Ramesh Nagar, Near Raja Garden, New Delhi, [PAN No. AAACH8678L] (hereinafter called "HERITAGE HOSPITALS" or "Heritage Hospital", which expressions shall unless repugnant to the context or meaning thereof be deemed to include its executors, administrators, Indian and overseas affiliates / subsidiaries and assigns) of the **Second Part**. WITS (IND)

Incubis and the Heritage Hospital are hereinafter collectively referred to as the "Parties" and individually as a "Party".

WHEREAS:

- A. The Heritage Hospital has acquired a healthcare facility at Sector 119, Noida, UP where the existing building consists of 2 basements, ground plus 9 floors including 2 service floors with a built up area of approx. 66,000 sq. ft. ("Project"). The Heritage Hospital is keen to convert the facility into a centre of excellence with a warm, inviting feel having optimal use of space, high durability, as well as clinical hygiene of international standards. The Heritage Hospital is also keen to add one complete floor as per available FSI as well as some additional space on the terrace with a temporary / pre-engineered roof.
- B. Incubis offers to provide its full suite of Architecture, Planning, Interior Design, Coordination/Management of MEP Services & related services as outlined in the scope agreed herein and communicated from time to time by the Heritage Hospital (collectively "Services") so as to bring the Heritage Hospital's vision to life and create an innovative hospital that is functionally efficient and aesthetically compelling, at par with the best such hospitals, worldwide.
- C. Incubis has agreed to provide the said Services to the Heritage Hospital in accordance with the mutually agreed premises, scope, deliverables and framework defined herein.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND MUTUAL AGREEMENTS AND COVENANTS CONTAINED HEREINBELOW FOR GOOD AND VALUABLE CONSIDERATION, (THE RECEIPT AND ADEQUACY OF WHICH IS HEREBY MUTUALLY ACKNOWLEDGED), THE PARTIES HEREBY AGREE AND UNDERTAKE AS FOLLOWS:

1. SCOPE OF SERVICES

1.1. Incubis will appoint and manage Kitchen Consultants, Landscaping Consultant and other professionals required by the Heritage Hospital in order to execute the Project, and coordinate all key inputs and drawings and be the single point of contact. MEP Consultants will be appointed directly by Heritage Hospital, hospital, however, Incubis will manage and coordinate their services and inputs.

1.2. ARCHITECTURAL FAÇADE & INTERIOR DESIGN

- 1.2.1. Incubis shall appoint its Architect-on-Record and shall provide services in respect to the following scope of works and as determined during interactions, discussions and information exchanged with Heritage Hospital' management
 - a. Façade Look & Feel upgrade derived from existing situation & constraints b.Interior Space planning, design and development as per revised allocation of spaces
 - c. External development / Hardscape and Landscape to the extent feasible

Detailed brief of the scope of works are as mentioned below:

1.2.2, Concept Design Stage

- Collate design brief from the Heritage Hospital through multiple rounds of discussions with all relevant stakeholders.
- Review concept design to develop a design option based upon the brief and various other scenarios. All the design recommendations should generally be as per JCI /NBC/ IS Codes, NABH.
- Prepare a conceptual level design with 3 options for building façade and internal circulation plans
- Interior design, space planning and development with reference to interior spaces, area program and requirements.
- At the tender stage, submit item wise budgetary estimate in line with design brief along with list of tender packages & vendors capable to deliver quality of finishes & aesthetics envisaged.

1.2.3. Schematic Design Stage

- Prepare sketches for building options identifying principal design elements for discussion.
- The benefits and constraints for each option shall also be provided.
- Prepare & discuss the schematic design options and advice on relative merits of various options. Finalize scheme in discussion with the Heritage Hospital and prepare preliminary framing plans.

- Conduct a 3D presentation for approval prior to tender documentation. (A total of approx. 20 nos. rendered stills for interior / exterior areas will be presented during this phase)

1.2.4. Design Development & Tender documentation Stage

- Coordination with the other design consultants in updating design information as the architectural plans and elevations evolve.
- Integration of MEP design and details (HVAC/ Firefighting and Fire detection/Fire suppression / CCTV /security /plumbing, sanitary, water supplies, medical services, etc. as defined in finalized scope) with Architectural drawings
- Design of fixed items of works, interior-related civil works.
- Signage and way-finding design as per scope.
- False ceiling design and details.
- Flooring design and details.
- Wall finishes design and details.
- Indoor plants locations only and recommendation of planter size and typology, if necessary

- 1.2.6. Equipment planning and their locations will be well thought through and multiple rounds of interaction with the key stakeholders shall be done to understand the requirements to make this an outstanding Multi Specialty hospital. Moreover, COVID-19 era precautions and requirements including those for external screening, sanitization, local containment and zone segregation, air handling, etc. shall also be incorporated into the design. The detailed space allocation program and outline of facilities will be consistent with the design brief shared by the Heritage Hospital.

- 1.11.3. Co-ordination with specialised Green Building Consultant appointed by the Heritage Hospital and providing then the desired information as and when required



- 1.11.4. Providing base drawings and design related data to liaison/ sanctioning architect appointed directly by the Heritage Hospital, in case fresh sanction drawings are required Actual sanction drawings for submission and facilitation of statutory approvals will be done by the liaison/ sanctioning architect under the guidance of Incubis
- 1.11.5. Provide design related information and corresponding drawings to facilitate Occupancy certificate as well as consent to operate by the concerned statutory authority. All related liaison and coordination will be done directly by the Heritage Hospital / liaison consultants appointed by the Heritage Hospital
- 1.11.6. Lighting fixture layouts based on the approved conceptual intent will be done by Incubis and all lux calculations will be done by the MEP consultant appointed by Incubis The same will also be validated via shop drawings provided by the approved lighting fixture suppliers via shop drawings they will need to submit before their orders for procurement are issued
- 1.11.7. Reasonable design and technical co-ordination with specialised agencies and consultants appointed directly by the Heritage Hospital for Site Survey & Digitizing of As-Built Drawings, NDT of the existing building and Structural Engineering. Incubis will keep such specialists and consultants apprised of the specific requirements of the project so that there is no delay in progress of Incubis' work.
- 1.11.8. Elevators & Dumb-waiter, if required, will be specified by Incubis
- 1.11.9. Fire and essential / statutory and all other required way-finding signage

The Parties agree that all other project participants and consultants shall remain fully responsible for the validity, technical accuracy, safety, reliability and completeness of their own / respective work.

2. SCHEDULING

- 2.1. Total design and execution duration for the Project is estimated at 12 to 18 months (approx.).
- 2.2. A detailed Time Schedule/ Gant chart shall be shared and agreed with the Heritage Hospital on start of the Project. This schedule will integrate with the Heritage Hospital's overall requirements and launch objectives. Incubis will aim to parallel process activities to the extent logical and feasible to achieve a compressed project schedule.

8. PAYMENT & GENERAL TERMS

8.1. Payment

a) The Heritage Hospital shall pay GST/ All applicable taxes on the Professional Fee/s

b) The Initiation Fees together with applicable GST, as specified herein are not-refundable and shall not bear any interest under any circumstances.

c) Incubis shall be paid its Professional Fees against completed stages / completed work in the event of the Project being abandoned/ put-on-hold by Heritage Hospital for any reason, no later than one calendar month after



completion of deliverables in the scope of Incubis or submission of concepts / with specifications / design documentation, drawings, whichever is earlier.

d) Payment/s for each of the Services in the scope of Incubis shall be made in the stages specified herein above consistent with the work done plus

reimbursable expenses/ extra charges, as agreed mutually.

e) Heritage Hospital shall ensure that payments reach Incubis' Office in New Delhi within 14 working days of receipt of an Invoice. The invoice shall be deemed to have been approved / accepted unless within 7 (seven) working days of receipt thereof, Heritage Hospital advises Incubis in writing detailing its objection to the whole or any part thereof. The Parties must promptly discuss the objection and agree on further requirements, if any.

f) Payments should be made by NEFT/Bank Draft/Cheques payable at Delhi, drawn in favor of: 'Incubis Consultants (India) Private Limited' along with a payment advice giving details of the remittance and TDS deduction, as applicable. Heritage Hospital shall bear any Bank Charges etc. for preparing

Bank Draft/s and/or for clearance of any Out Station Cheque/s.

g) No deductions shall be made from the fee of Incubis on account of BGs, retention, penalty, liquidated damages, part rates or other sums withheld from payment or recovered from implementation agencies/ suppliers/ contractors or other Consultants working on the project.

h) In case the area to be designed increases more than 10% of assumed BUA an additional design fee will be charged on a pro rata basis + GST, or as

mutually agreed

i) In case the Project extends beyond 18 months from date of initiation solely on account of force majeure conditions being reasons beyond Incubis' reasonable and foreseeable control, an additional 12% p.a. will be charged on the unbilled part of the Project fees / design fees provided the balance Services are provided in a timely manner to the satisfaction of Heritage Hospital.

9. Commencement of Work

Start date for the Project shall be immediately on receipt of the Initiation Fee together with applicable GST, as specified herein, accompanied by Heritage Hospital's Work Order / Approval Letter/ Signed Copy of this Agreement, clearly accepting all the terms outlined herein.

10. Coordinator

Heritage Hospital shall nominate one sufficiently senior fully empowered representative as Coordinator who shall be responsible and authorized to coordinate within Heritage Hospital organization, collect data, provide information, local assistance and support; to discuss and finalize proposals and for their timely implementation The Coordinator shall discuss drawings and documents submitted by Incubis and give decisions promptly to avoid unreasonable delay in the progress of Incubis' work.

The Coordinator shall also be responsible for:

>Coordination with Structural Engineer, other consultants appointed directly by Heritage Hospital as well as Heritage Hospital's in-house team and facilities and any other resources critical to project implementation



>Arrange liaison with site management / project managers / structural engineers, other agencies, consultants, contractors directly appointed by HERITAGE HOSPITALS

>Coordinate timely hand over of Medical Equipment Dimensions and related data

>Directly appoint and make timely payments to the MEP and Structural Consultants so that their work proceeds generally in sync with progress of Incubis' deliverables

>Coordinator will compile and track all design and site-works related queries – These will normally be resolved during the weekly site meetings or within 3 to 4 working days thereafter – Design inputs will be noted / sketched into the coordinator's site-book or confirmed by Incubis subsequently in the form of a formal drawing / specification release

11. Termination

In case payment/s (inclusive of GST and Interest etc.) are delayed beyond 30 Woking Days after the due date in terms of this Agreement, Incubis has the right to suspend work, or at its sole option, terminate service under this Agreement by giving 15 (fifteen) days' notice. The Heritage Hospital shall, however, remain obliged and liable to pay up all sums due hereunder/ against work / drawings submitted/stages completed. Heritage Hospital may terminate this Agreement at its discretion in the event of breach of this Agreement by Incubis or failure to perform its Services within applicable timelines and as per applicable laws, by giving a 10 (ten) days' prior notice.

12. Representations and Warranties

Incubis represents and warrants as follows:

- a) It shall deploy and engage suitably experienced and competent personnel and such number of personnel as may reasonably be required for the performance of the Services;
- b) All employees engaged by Incubis shall be in sole employment of Incubis and Incubis shall be solely responsible for their salaries wages, statutory payments, etc. and undertaking necessary compliances in relation thereto. That under no circumstances shall Heritage Hospital be liable for any payment or claim or compensation of any nature to the employees and personnel of Incubis;
- c) It shall be responsible for all negotiations with personnel relating to salaries and benefits, and shall be responsible for assessments and monitoring of performance and for all disciplinary matters;
- d) It shall regularly provide updates to Heritage Hospital with respect to the Services and shall regularly, with the personnel designated by Heritage Hospital, discuss and review its performance at such intervals as may be required by the Heritage Hospital;
- e) It shall use all reasonable steps to ensure that Services to be rendered hereunder will be of quality and standards as mutually agreed between the Parties from time to time;



- f) It shall ensure compliance with all applicable laws in providing the Services, including, *inter alia*, labour laws, EPF, etc. and shall hold the Heritage Hospitals fully indemnified in this regard.
- g) It has all required approvals, permissions, licenses, etc. needed for carrying out all its obligations contained herein.
- h) It undertakes to forthwith cure any defects identified by Heritage Hospital in the Services as and when requested at its own cost and expense.

13. Indemnity

Incubis agrees and undertakes to fully indemnify and hold harmless Heritage Hospital and its staff, directors, etc. from and against any losses, liabilities, actions, damages, claims, proceedings, costs and expenses, etc. incurred or suffered on account of (i) breach of its obligations, covenants and responsibilities contained herein, (ii) any misrepresentation, (iii) any breach or violation of applicable laws, (iv) any design or other flaw which affects the operations of the Project, and /or (v) any improper or gross negligent performance, act of commission or omission by Incubis and/or any of its personnel leading to a third party liability. All project participants and consultants / specialists whether appointed by Heritage Hospital or Incubis shall remain fully and solely responsible for the validity, technical accuracy, safety, reliability and completeness of their own / respective work and deliverables

14. Force Majeure

Force majeure shall mean any unforeseeable and exceptional situation or event beyond the reasonable control of the Parties hereto which directly prevents either of them from performing any of their obligations hereunder, and which was not due to error or negligence on their part or on the part of a subcontractor, and could not have been avoided by the exercise of due diligence.

15. Disputes

All disputes, differences arising out of this Agreement shall be resolved through mutual discussions. In the event of mutual agreement not being possible to be arrived at after the discussions, the same shall be referred to a sole arbitrator to be mutually appointed by the Parties. The provisions of the Arbitration and Conciliation Act, 1996 or any modification thereto or re-enactments thereof shall govern the arbitration proceedings. The venue of such proceedings shall be Delhi and the proceedings shall be in English. The arbitration shall be binding in nature.

16. Confidentiality and Design Rights

GURUGE

The Design Rights for the concept will remain with Heritage Hospital. Incubis retains the right to publicize executed works once they are implemented and are in the public domain with prior permission from Heritage Hospitals.

17. Personnel

The Heritage Hospital/ Incubis agree to desist from engaging the services of each other/s personnel (whether full/part-time/contractual or as consultant, retainer, advisor, etc.) for a period extending up-to at least five years hereof or three years

after completion of the project / assignment / work defined herein, whichever is later.

18. General Pre- Requisites:

site.

- I. The scope hereof is limited to the services identified herein. Any addition to this scope and/or change in requirement desired by the Heritage Hospital including addition of Optional Services shall comprise "extra work" and be charged accordingly. Any other expenses undertaken on Heritage Hospital's request, such as for structural engineering/ structural design, additional / detailed site-specific design adaptation, MEP Services, major rework of any approved concept/ drawings, artworks, photography, proofing, bulk reprography & binding, couriers, plotting of drawings (larger than A1 format), high resolution image scanning, any additional / new 3-D renderings and CAD simulations (Exceeding a total of approx. 20 nos. rendered stills for interior / exterior areas), colour artworks / graphic templates, prototyping, cost of models, structural design, if required, ISD calls, etc. will be charged on cost plus basis and should be settled immediately by the Heritage Hospital.
- **II.** Additional expenses exceeding INR. 25,000/- will be undertaken only on Heritage Hospital's request accompanied by a note approving the corresponding charges. Payment for additional expenses will be in advance or as per a mutually agreed schedule.
- III. All contractual arrangements for actual execution and financial transactions with third parties shall remain the sole responsibility of the Heritage Hospital. In case the Heritage Hospital wishes to route payments to nominated third parties / consultants through Incubis, an additional charge of 20% plus any applicable taxes shall be levied as administrative overheads / financing charges.
- IV. Periodic Inspection includes the following: >To provide reasonable periodic visits to ensure that the project proceeds generally in accordance with design and conditions of contract and to provide clarifications, interpretation of drawings/ artworks, samples and specifications as may be necessary. Such inspections may be through site visits, conferences and meetings as and when required during the course of construction of works and shall not normally exceed 2 to 3 hours @ each event. These meetings may be organized at the offices of Incubis or by Visits to the offices of Heritage Hospital or at Project
 - > At least 20-25 site visits will be made within a duration of 10 months as per progress of work at site— Additional visits will be chargeable at INR 10,000/- + GST, per additional site interaction after discussion and mutual resolution of such additional fees with the Heritage Hospital.
- V. Inter-City Travel, if required, on behalf of the Heritage Hospital, if authorized
 - a. Only Professional Executives (Architects, Engineers &/or Designers) would be deputed by Incubis for Out Station Travel/ Site visits / coordination meetings, as required/ authorized.
 - b. The Heritage Hospital will arrange business hotel or equivalent boarding / lodging facilities for Incubis' executives (during their out station visits for this Project) and also arrange for local transportation by AC Car/Taxi, all in advance. In the event the Heritage Hospital does not arrange for the above, expenses as incurred by INCUBIS shall be reimbursed on presentation of

invoices/bills etc. Any applicable FBT or other statutory levies on such account will be borne by the Heritage Hospital.

c. For all out-station visits by Incubis' executives, an outstation charge of INR.10,000/- (+ GST, as applicable) per man-day shall be payable to Incubis.

- d. The Heritage Hospital will arrange return air tickets for Executives of Incubis, in advance. If air services do not exist, then travel shall be by First Class a/c rail or a/c car.
- e. All arrangements for travel, including visa & immigration related expenses (if applicable), all board & lodging, local conveyance, out of pocket expenses etc. will be made and paid for directly by the Heritage Hospital, in advance. In case of any international travel, a per-diem of USD 150/- +GST will be payable per man-day in addition to OPEs.

19. Correspondence

All contractual and/or commercial communication/s and correspondence shall be addressed only to the offices of Incubis and Heritage Hospital specified herein unless intimated otherwise.

20. Validity

This Agreement shall become effective from the date of execution hereof and shall remain valid for a period of 18 months therefrom unless terminated earlier in accordance with the terms of this Agreement.

21. Confidentiality and Safeguard of Property

Incubis agree that the information, records, documents, etc. provided by Heritage Hospitals under this Agreement and all trade secrets, intellectual property, etc. belonging to Heritage Hospitals is confidential and without taking the consent of Heritage Hospitals they shall not at any time during the association divulge either directly or indirectly to any person(s), firm or company, business entity, or other organization whatsoever, any confidential information that they may acquire in writing/orally or in any other form during the course of such association or otherwise concerning Heritage Hospitals's business, property, contracts, trade secrets, clients or affairs. The obligations set out in Clause 20 above shall not apply to confidential information that:

- a. is or becomes publicly known other than through breach of this Clause; or
- b. is in possession of the receiving Party prior to disclosure by the other Party; or
- c. is independently developed by the receiving Party; or
- d. needs to be disclosed to professional advisers or in accordance with the order of a competent court or administrative authority; or is required by law, judicial court, recognized stock exchange, government department or agency or other regulatory authority.

22. Entire Agreement

GURUGE

Each party acknowledges that it has read this Agreement, fully understands it and agrees to be bound by its terms and further agrees that it is a complete and exclusive statement of the agreement between the Parties, which supersedes all prior understanding and all the other agreements between the Parties relating to

the subject matter of this Agreement. No amendment, supplement, modification or clarification to this agreement shall be valid or binding unless set forth in writing and duly executed by all the parties to this agreement.

23. Assignment

Save as set out herein, the Parties shall not assign or purport to assign or otherwise deal with any of its rights and obligations hereunder, except with the express prior written consent of the other party.

24. Waiver

Unless otherwise expressly stated in this Agreement, the failure to exercise or delay in exercising a right or remedy under this Agreement shall not constitute a waiver of the right or remedy or a waiver of any other rights or remedies, and no single or partial exercise of any right or remedy under this Agreement shall prevent any further exercise of the right or remedy or the exercise of any other right or remedy.

25. Independent Contractors

Incubis is an independent contractor of, and not an employee, agent or authorized representative of Heritage Hospitals. No agency, partnership, joint venture, employer-employee relationship, or other business combination between Incubis and Heritage Hospitals is intended or created by this Agreement.

26. Anti-Bribery / Anti-Corruption

The Parties agree that, at all times in connection with and throughout the course of the Agreement and thereafter, they will comply with and that they shall take reasonable measures to ensure that their subcontractors, agents or other third parties, shall comply with all applicable anti-bribery regulations and anti-corruption laws/policies and further acknowledge that giving and taking bribes shall lead to criminal proceedings in accordance with applicable laws.
