Additional Conditions

A. Water (Prevention and Control of Pollution) Act, 1974

- 1. Industry shall operate and maintain the effluent treatment plant regularly and ensure the treated effluent quality within prescribed standards all the time. Industry shall not discharge effluent outside the premises in any circumstances. Zero discharge condition shall be maintained all the time.
- Industry shall ensure the compliance of guidelines issued by CPCB/MoEF & CC for coal washery (i.e. installation of rain guns wind breaking screen, wheel washing system, CCTV Camera, pucca approach road, catch drains, settling pit etc).
- 3. All the solid waste shall be disposed off in environment friendly manner as per rule.
- All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
- 5. Industry shall comply with the provision of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 (as amended upto date) from the Board and comply with the rule.
- 6. Industry shall ensure transportation of coal reject/middlings / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall ensure transportation of coal in mechanically covered vehicles before 12/07/2023.
- 7. Industry shall enhance the capacity of rainwater harvesting systems to increase the ground water recharge.
- 8. Industry shall follow notification/order/guideline issued by MoEF & CC for use of middlings & rejects.
- Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) Amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.
- 10. Extension of tree plantation shall be carried out in the open areas available within and around the plant premises in during monsoon season. Fruit bearing species like mango, tamarind, guava etc. shall be given preference in this regard.
- 11. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Vinay Rai, Asst. Vice President of M/s ACB (India) Ltd, (Formerly Known as M/s Spectrum Coal & Power Limited), Village Ratiza, Taluka Katghora, District Korba (C.G.).

- 12. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.
- 13. In case, if the capital investment is increased by such amount that the total investment exceeds the range for which renewal fees has been paid, the industry shall have to pay the difference amount of renewal fees for the corresponding block years.
- 14. In case, the prescribed fee payable is amended in future, the industry shall be liable to pay the difference amount for corresponding block years.

B. Air (Prevention and Control of Pollution) Act, 1981

- 1. Industry shall ensure the emission of particulate matter i.e. 50 Mg/Nm³ within the limit prescribed by the board all the time.
- 2. Industry shall maintain the ambient air quality within the prescribed limits.
- Industry shall ensure the compliance of guidelines issued by CPCB/MoEF & CC for coal washery (i.e. installation of rain guns wind breaking screen, wheel washing system, CCTV Camera, pucca approach road, catch drains, settling pit etc).
- 4. All the solid waste shall be disposed off in environment friendly manner as per rule.
- 5. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
